

# BILL OF THE IMPERIAL DIET

---

## THE TUVYIC ACT

**[Not enacted/Day enacted in Imperial calendar]**

Introduced in the Commons.

With Ess see of passage in the 22nd Diet.

### INTRODUCTION

With the second edition of the Codex Iurius Canonici Danielus Pontifex (henceforth called Canon Law) released several years prior, Canon Law has since clarified the Canonist position regarding Angelic magical tethering. According to Canon Law,

Chapter §2. Veneration that creates a magical tether between the venerator and the venerated is always forbidden.

In “A VERDICT ON THE XANNIC PALADINS” written by former the Auditor of the Tribunal for the Church of Canon before the second edition of Canon Law, the Verdict defined Xannic Paladins (defined in the ORC as the Magic of Xanism in 802.14E) as descendants who received magical power from the Angel Xan through intercession.

This group of descendants, through intercession, receive magical power from the Aengul Xan to uphold his ideals, following their Paladin creeds.

Furthermore, the Xannic Paladins committed a terrorist act against the Imperial Family, hurling a meteorite upon the throne room. According to the special edition of the Leuven Times, “ZANN CULTIST ATTACK ON THE AUGUSTINE PALACE,”

It was by pure miracle of chance that the meteor did not strike the bedchambers of the Emperor himself; and it was by pure malice that it was called down originally.

It is deemed necessary that we impose protections against further attacks, while keeping in mind not to keep a large audience accountable for the actions of a few in solitary.

### SECTION I:

*Definition of Xannic Paladins directly from the ORC*

1. **Magic of Xan** where an individual attempts to manipulate energy given or borrowed from the daemonic being Xan (High Imp. Janus), typically in use to manipulate or remove corrupted voidal energies.

## SECTION II:

### *Ensuring future protections against Xannic Attacks*

1. A list shall be made, fully accessible, to the Ministry of Justice and Ministry of War, which will entail a definitive, registered, description of all practitioners and users of the Magic of Xan, within the Empire.
2. A commission shall be created under the Justice Department, named the [insert name], charged with the official investigation of all known Xannic Paladins and Xannic activities.
3. It shall be a felony to use or be a user of the Magic of Xan within the Empire without first turning in documentation to the Ministry of Justice and Ministry of War containing at minimum a description of one's self, age, and granted abilities, to be bound to law as ORC [Number here].

Upon introduction to a uniformed Orenian soldier, Orenian auxiliary force member, or Magistrate of a settlement or their deputies, or upon arrest or questioning, users of the Magic of Xan must declare their ability to utilize said magic and affinity towards the Xannic Paladin organization. To fail to do so shall be a misdemeanor, to be bound to law as ORC [number here].
