Abstract

The content presented here should be the same as in the abstract file. The content of the abstract should clearly present the main findings and novelty of the research. The layout of abstracts is in straight A4 format, with 2.5 cm upper and lower borders and 2.8 cm left and right borders. The number of words is limited to 300 in English (500 in Chinese). The abstract will be published in the proceedings.

The English and mathematical fonts are Times New Roman. The research title is 14pt bold and centered. The section title is 12pt bold, aligned to the center. Leave one blank line between the sections. The distance between the section title and the text is 0.5 line. The text is 12pt, indented by 2 characters on the left, justified, and using single-line spacing.

1. Introduction

Authors are suggested to use this file as the template for their submitted paper. The structure of the paper should follow this sequence: "Introduction", "Research Methodology", "Results and Discussion", and "Conclusions". The paper's layout is straight A4 format, with 2.5 cm upper and lower borders and 2.8 cm left and right borders. The full text should have at least 6 pages and not exceed 8 pages (including pictures, tables, and references). The paper must be submitted to the conference website in the word format (.docx) with the file name the same as the research title.

The English and mathematical fonts are Times New Roman. The research title is 14pt bold. The section title is 12pt bold, aligned to the left. Leave one blank line between the sections. The distance between the section title and the text is 0.5 line. The text is 12pt, justified, and uses single-line spacing. The paper's references should follow the American Psychological Association 6/7th Edition (APA 6/7th). Examples of formats for citing literature: Chen (2024), (Chen, 2024), Chen et al. (2024).

2. Research methodology

The font of the included figures and tables' titles should be in Times New Roman, 12pt. The figure number is placed below the figure and centered; the table number is at the top and centered, as shown below.

When quoting figures and tables in the text, use the figure and table numbers. The figures and tables should be of high quality in terms of resolution and presentation.

3. Results and Discussion

Authors should present the key findings of their research with tables and figures. The authors should clearly clarify whether their study has already been accomplished (had experimental results) or is ongoing so that reviewers can understand the status of the research.

4. Conclusions

The conclusions should indicate the novelty of the research and how the research contributes to the construction industry or the scientific community. As mentioned above, the length of the paper should be limited to 8 pages at the maximum.
