Harm Reduction Efforts-

- o Steve Berry, SWODA
 - o SWODA Narcan Hub- We have Narcan, Fentanyl Testing Kits/Strips and Xylazine Testing Strips.
 - o SWODA made referral to Panhandle Narcan Hub for staff training: Northwest Domestic Crisis Center (Guymon).
 - o COSSUP 21 Grant-
 - o Vending Machines- We still are not getting enough data from machines, so we are trying to change the signs to improve participation. Since the last meeting, we got data from 22 boxes dispensed from 3 different machines. The highest volume was from Jackson Co Mem Hospital in Altus (12), and then Operation Cares in Frederick (10). However, we restocked the JCMH machine with 3 dozen boxes.
 - o Recruiting Host Sites- Steve met with Variety Care Clinic (Ft. Cobb), Carnegie Hospital, Warrior Mart (Anadarko), and CareFirst Wellness Associates/Clinic Pharmacy (Anadarko) about hosting vending machines. Attended Caddo Co Interagency Coalition in Anadarko.
 - o Lock Bags, At-Home Disposal Kits- Distributed at Wellness Symposium (Altus), Kids Kites & Frights (Anadarko), Fall Festival (Snyder).

Treatment

 - o Mobile Unit Updates- The COSSUP24 application, if approved, would fund continuation of the Mobile Unit Operations. SWODA retains ownership of the Mobile Unit and will continue to seek opportunities to keep this program running.
 - o Amber Wolfe, an APRN in the Variety Care Clinic of Ft Cobb is prescribing Suboxone for patients with OUD.
