## **COURSE TYPE:**

Private lessons; active participation and interaction in a one-on-one setting with the instructor.

## **REQUIRED MUSIC AND EQUIPMENT\*:**

Etude books, solo music, orchestral excerpts, etc. as assigned by the instructor. Additionally, there will be a significant element of ear training.

## **ADDITIONAL COURSE MATERIALS\*:**

Students are required to seek out recordings of assigned music to facilitate the learning process. Also, other equipment may be required, such as mouthpieces, instruments, mutes, valve oils, and other supplies as recommended by the instructor.

## **LEARNING OBJECTIVES:**

By the end of each semester, successful students should have:

- come to lessons each week fully prepared to play the music assigned.
- listened to numerous recordings of various trumpet players, non-trumpet players, chamber ensembles, vocalists and orchestras as assigned
- devoted as much time as necessary to complete the assigned tasks and show measurable progress

Grading of the research will be reflected in the assignment grade.

## **JURY REQUIREMENTS**

Trumpet majors are required to perform a jury for the brass faculty during exam week each semester. Requirements for the jury could include scales, etudes, orchestral excerpts, solos, and possibly sight-reading. The instructor and student will decide on repertoire prior to the jury examination. Minors are not required to perform a jury but can schedule one if they wish. **Juries are graded on a Pass/Fail basis** but this is subject to change.

## PERFORMANCE / JURY ATTIRE

You are expected to present yourself in a professional manner at all performances and juries. Please be dressed in a professional outfit for all performance/presentations.

**Scale Tests:** Scales are required each week in lessons for the first two years of study. Each student is required to pass scales and arpeggios each semester. **The student will be tested on all major and minor scales/arpeggios at the end of each semester.** Semester one is with the scale sheet, semester two is major scales and arpeggios memorized with minors off the sheet, semester three all scales and arpeggios memorized with the option to test out semester four scale test. Semester four is all memorized. Test in lesson or separate time.

## LISTENING ASSIGNMENTS

Each semester students will have listening assignments/quizzes to help familiarize them with standard repertoire for the trumpet. This will take place during Perform Repertoire & Pedagogy.
