A. You & Your Campaign

1. Briefly tell us your background or biography.

I'm a long time Bay area resident. I'm of Iranian ancestry and have deep roots with the Iranian peoples movement for liberation, both from imperialist forces and the dictatorships of the Shah and clerical regime. I am a physical therapist, I own and operate a community clinic in downtown Berkeley dedicated to delivering quality care to all our community including MediCal and Medicare patients and most other insurances. We also have the rock bottom cash pay price in the area, making sure PT is accessible to all. I am a single mother and have raised 2 boys alone for the last 12 years. I have been very engaged in progressive grassroots organizing in Berkeley the majority of this time.

2. Why are you seeking this office?

Running for the Rent Board is a natural evolution of my work with my patients and the community. I have heard horrific stories of wholesale displacement and eviction from many of those I care for. These interactions have led me to my advocacy work and it has become my mission to protect and preserve my community. I believe that stable housing is an essential part of health and wellness.

I have a background of day to day contact through my medical work, they are my natural constituency. I am familiar with their needs. In addition I am a home-owner and a renter because I rent our clinic space and have had to deal with the most abusive landlords of this city.

I continued to the end with phone banking.

Environment and Green New Deal

Housing

62. The financialization of the housing market, the privatization of socialized housing models, the subprime mortgage meltdown and the further crime of our government to bail out the banks. Compounded with the deregulation of the housing and banking sector, this has all led to the inability of the working classes to ever realize the dream of home ownership. And led to millions of people becoming house-less in the streets of our cities. At the same time we have a tenants movement that despite its growing ranks has been muzzled and not supported by many labor unions, some "leftist organizations" and the BIG "Democratic machine." The YIMBY lobbying group which could also be named "The Land use lobbying group for the BIG TECH industry" Has become very influential and powerful while working with the forces of capital at the state level and pass legislation to dictate statewide land use policy they have changed the faces of our communities in the interest of developers.
