

Terms of Service

Interpretation

The words in which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in the plural.

Definitions

For the purposes of these Terms and Conditions:

Application means the software program accessed by you on any electronic device with the name "Easy In-House Ranked"

Account means an account created for You to access our Service or parts of our Service. Our Service only has accounts created through the Third-party Discord.

Affiliate means an entity that controls, is controlled by or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interest, or other securities entitled to vote for the election of directors or other managing authority.

Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to the owning entity of the Application.

Country refers to United States
