I voluntarily select to accept and assume of risk of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designed to , (b) while serving in a non-playing capacity as a team member during practice or play by other team or by players on the team, and (c) while on or upon the premises of any and all of the fields arranged for by my team for practice or play.

I hereby release, discharge and agree not to sue NJICA, or its officers, agents, servants, association, employees, or any person or entity connected with NJICA for any claim, damages, costs or cause including but not limited to the negligence breach of contract or wrongful conduct of the parties hereby released.
