# **October 8th Professional Development**

In an effort to provide relevant professional development for our CTE teachers, this year we have contracted with the National Alliance for Partnerships in Equity (NAPE) to provide their curriculum titled, "The Power of Micromessages in Marketing, Recruitment and Success in CTE"

This six-hour program will take virtually and include a stipend of \$194.58 for those teachers who are not paid by their districts for the state inservice day. The Zoom event will take place from 8:30am - 3:30pm with an hour lunch from 11:30am-12:30pm.

Program Objectives - During the workshop, participants will:

- Discover how cultural stereotypes affect individuals,
- Uncover implicit biases and their effects on students' course and career decisions.
- Learn and apply key concepts relative to the power of micromessages in order to build individuals' self-efficacy, especially in career fields outside of the perceived gender norm, and

• Identify and plan one to two specific strategies to implement in interactions with students (full day implementation).

### **Grouptrail for Work-Based Learning Dashboard Project**

C-TEC will be going with Grouptrail for its vendor to create and provide training for a Work-Based Learning Dashboard.

The dashboard will be a one-stop-shop for schools and core partners to collaborate, share resources and opportunities, and maintain a shared database of business & industry partners and the ways in which those partners are willing to engage with students by location, grade level, type of activity (job shadow, mentorship, cooperative work experience, clinical practicums, pre-apprenticeship, employment, on-the-job training etc.

#### **Purpose**

- 1. Support the implementation of equitable work-based learning opportunities for our secondary programs of study
- 2. Connect programs of study with partners who are providing career-connected learning services to underserved populations

#### Why Now?

Clackamas County has an infrastructure gap around supporting industry partnerships, which are necessary for supporting CTE advisory committees and providing work-based learning opportunities, both of which are required for Programs of Study. Students in well-established programs occurring in some districts/specific programs have much better access to industry partners than others.

We can continue with the status quo and hope that schools can offer enough opportunities to equitably serve all the students who need them. Or, we can take the steps to build a common resource and tool to give all of our program of study students the best chance possible to access quality work-based learning.

#### **C-TEC Perkins Goals**

- V. Support the development of Work-Based Learning (WBL) opportunities for regional CTE students.
- VI. Share and align resources that will increase access to career and work-based learning opportunities for regional CTE students.

### **Yeary Program of Study Updates**

Each year, every program of study in the state must be updated, or at least verify that no changes have been made to the approved program of study. Updates could be changes in titles of courses, new courses offered, or even updated course numbers.

On November 1st, ODE will be switching to a new CTE Information System. There will be a lot of positives due to this needed update. The change will also come with some added work for our CTE teachers. Teachers will be required to go into the data system and recreate the course matrix/crosswalk. This is the document that's submitted at the initial stages of starting a program where we can see what standards are taught in what classes. This will not be a document anymore but rather live in the new information system and can be more easily accessed.

ODE plans to provide training to our lead teachers in each program so they can provide yearly updates. Those updates will be approved by your building administrator and then passed along to the regional coordinator.

Stay tuned for more information regarding the training that will take place.

# **Program Renewal Schedule**

Beginning in the spring of 2022 the following programs will be required to be renewed:

- Architecture & Construction
- Business, management & administration
- Information & Communications
- Manufacturing

The goal is to have each group of teachers from their respective programs works collaboratively with one another to go through the process. As some of you know, the state has been working with industry stakeholders to help develop statewide programs of study framework and ensure that our students around the state have access to quality programs, more consistent connections to college credit, and better alignment with business and industry needs.

Funds for substitutes have been budget so these groups have time to get together complete the renewals.
