#### 6. LNC Report: Ed Marsh/Steven Nekhaila

Representative Marsh discussed the upcoming LNC meeting – fundraiser in Aurora, CO. You can watch the meeting streamed on LP.org. National Convention is in 75 days. Encourages everyone to think about regional caucuses at the convention, where we will elect a new Region 2 rep.

Chair Miralles asked Ed to discuss vote regarding Arvin's suspension vote. The vote did not pass, and Representative Marsh did not support the suspension, rather leaving the decision to the delegates at upcoming convention. Final vote was one vote away from getting the 2/3 it needed to pass.

Rep. Ramsey asked where members can find proposed platform and rules changes for National Convention – Rep. Marsh said it should be posted on LP.org very soon and he will let us know when it is posted.

Representative Nekhaila did not have anything else to add at the moment. Will not be attending the LNC meeting in CO.

Deadline for re-affiliation passed with several counties not turning in paperwork. We are losing Indian River and Sarasota Counties until further notice. 4 counties total intend on re-affiliating but are late – Clay and Manatee turned them in prior to this meeting so there will be a vote to affiliate them tonight, still waiting on paperwork for the other 2 late counties, which are Duval and Monroe. - 2. Grant the Candidate Committee a budget of up to \$2,000 to send a direct mail campaign by contracting with LadyPrinting, a Florida-based printing and mailing company, to all Libertarian Party voters eligible to run for elected office in the Operation's districts listed by

the Candidate Committee; and

3. This budget authorization expires on May 15, 2018."

Title: Motion to amend Standing Rules to create an Article XIV titled "Selection of

Presidential Electors"

Mover: Marcos Miralles, seconded by Shawn Elliott

Text: I, Chairman Miralles, move to amend the Libertarian Party of Florida's Standing Rules to create an Article XIV, which shall be entitled "Selection of Presidential Electors" and which shall read:

"Each qualified member of the LPF EC who accepts service as an LPF Presidential Elector shall be appointed as such. Each member of the LPF EC who does not accept service as an LPF Presidential Elector shall select a qualified and willing LPF member to be appointed in their place.

The Chairperson of the LPF shall select the remaining candidates for approval by the EC. No more than three (3) candidates selected by the Chairperson shall come from the same region.

Each appointee shall be bound by a written oath to vote by ballot for the nominees of the Libertarian Party at the location specified and on the date selected by Congress, and shall have been, prior to their selection and continuously through that date: an LPF member, an LPF elector, and a subscriber to the LPF Non-Aggression Pledge. Appointees deemed by the Secretary and confirmed by the Chairman to be unqualified at the time of their selection or to have become unqualified thereafter shall be void. The EC shall appoint by resolution the final list of Presidential Electors and alternates by 15 August of each presidential election year.

The Chairperson of the LPF shall file a certificate within two (2) business days of that appointment to the authority specified by Florida statute, naming the LPF Candidates for President and Vice President and the appointed LPF Presidential Electors and alternates so that its receipt and sufficiency can be confirmed before the Governor's deadline to appoint Presidential Electors."

Title: Motion to appoint Steven Nekhaila as alternate to LP Platform Committee

Mover: Marcos Miralles, seconded by Josh Folsom.

Text: I move to appoint Mr. Steven Nekhaila, of Monroe County, to serve as the Alternate Member to the Platform Committee of the Libertarian Party.

Disposition: Motion passed unanimously.

Motion No.: 558

Title: Motion to set a deadline for motions to the EC Mover: Joshua Folsom, seconded by Shawn Elliott.

Text: I move to create Article V Section 9 of the standing rules to read,

Members of the Executive Committee must submit prior to midnight of the 5th day preceding a regularly scheduled executive committee meeting, per Article V Section 1 of the standing rules, any motions to be included by the secretary in the agenda.

This section shall not be construed to impair the Members' normal rights to propose motions, nor construed to impair Members' ability to conduct business under Article V Section 2 of the same.

Text: I move that the LPF contribute \$5,000 to Randy Wiseman's gubernatorial Campaign.

Disposition: Chris Rose motions to amend to strike "\$5,000" and insert "\$1,000". John Shuey seconds. Omar moves to call the question. Josh Folsom seconds. Motion to call question passed with one abstention, Fred Coulter. Motion to amend fails with one abstention, Fred Coulter.

Main motion fails with 6 ayes (Omar Recuero, Alison Foxall, Josh Folsom, George Lebovitz, John Shuey, and Suzanne Gilmore) and 11 Nays (Brandi Hicks, Chris Rose, Greg Peele, Mari Morrell, Spenser Garber, Ryan Ramsey, Mike Cassidy, Mark Rodriguez, Char-lez Braden, Shawn Elliot, Steven Nekhaila. One abstention: Fred Coulter.
