

# Harbor Holistic

## Mission Statement

At the center of the bustling main center of Sector Vremaja is a statue of the Idama. At its base is the engraved plaque which reads both as a quote of the Idama, and as a mission statement for the Astrahus Citadel built for the congregation of many faiths:

*“Ida is a path, but Intaki are expected to walk it themselves.”*

The **Harbor Holistic** is a project with a single goal in mind: To unite the many faiths of humanity and share civil discourse between them for the sake of sharing knowledge, enlightenment, and unity. The Administration of the Harbor Holistic initially started this mission after noticing several peculiar similarities in the faiths, and thus established a venture to pursue common grounds between the vastly different peoples of New Eden. It has since evolved as a project to allow safe-ground for all faiths, and to allow them to share their budding cultures in neutral ground. It is the hope of the administration and its founders that perhaps one day the miseries of the world may be brought to an end by the pursuit of understanding, prosperity, and knowledge.

## A Word from Security

For the purposes of this document, ‘Patron’ is defined as any member, guest or otherwise, who would walk the halls of the Harbor Holistic. It does not denote payment, subscription, or membership to the Harbor Holistic, as such is inferred merely by being present through the use of sponsored advertisements in Sector ‘Krish’ docking facilities.

The Harbor Holistic is an open avenue to all forms of religion, faith, and spirituality. Whereas ALL patrons and practitioners are irrefutably subject to extensive background checks - regardless of origin or creed - all are welcome in the Harbor’s open doors, so long as they follow **The Grand Principles**, mentioned later in this document. Though patrons are strongly encouraged to follow the Amendments, the administration at Harbor Holistic understands that humans are not infallible, and afford each patron a certain degree of error. Ill-afforded, however, are those who would seek to abuse the sanctuary for what it is, and patrons may be forcibly removed and/or barred access at the administration’s sole discretion.

# The Grand Principles and Amendments

In an effort to encourage amicable terms amongst all its patrons, both permanent and interim, a set of rules and regulations have been established, known as '**The Grand Principles**', and following them a set of amendments. **The Grand Principles** are intentionally concise, and are not open to subjectivity, relativity, nor interpretation outside of the administration, and are maintained at the administration's sole discretion. **ALL PATRONS** are expected to follow **The Grand Principles** to the letter, and the amendments to the best of their ability.

- ***No manner of violent behavior shall be tolerated, whether applied or intended, save reprieve from imminent bodily harm.\****
- ***Recognize the right of private judgement in religious matters.***
- ***Accept the liberty to uphold one's religious opinions and forms of worship.***
- ***Accept the liberty to enjoy all social privileges without regard to religious differences.***
- ***Refrain confusion of tolerance and validation.***

*\*With exception to Administration-approval, such as the Arena in sector 'Agni'. Ritualistic ceremonies, such as the controversial 'Tea Maker Ceremony', are permitted only with prior approval from the Administration, and must be conducted in areas ascertained by the Administration to be of little impact to other patrons.*

The Harbor Holistic adopts amendments frequently on an as needed basis, governed and maintained solely by the administration and its discretion, to provide a safe and welcoming atmosphere for its patrons. The following amendments have been established as a charter for patrons to better understand both our mission, and the environment at the Harbor Holistic:

- 1.a - Allow others to freely hold different beliefs and speak freely of their belief.
- 1.b - Allow others to freely change their religion, or denomination, or beliefs.
- 1.c - Allow other to practice their religious faith, within the statutes of **The Grand Principles**, including freedom of assembly, and freedom to practice required rituals.
- 1.d - Accept that followers of various religions consider their own beliefs to be true.
- 1.e - Make a reasonable effort to accommodate other patron's religious needs.
- 1.f - Accept that there is often a lack of consensus for which the definition of terms in faith may apply.
- 1.g - Accept that religions, faiths, and spiritualities differ greatly in their beliefs and practices.

- 1.h - Refrain from the belief that all sets of religious belief are equally true.
- 1.i - Refrain from the belief that all faiths are equally beneficial or equally harmless to society, or their followers.
- 1.j - Allow for constructive criticism of religious practices of other patrons.
- 1.k - Allow for civil discourse about a patron's beliefs to others.
- 1.l - Refrain from ignoring a patron's religious ideas.

Though subjective in both their application and enforcement, there exist a set of amendments for civil discourse. These are among a few generated to help guide the flow of conversation between those of different views and to discourage the use of fallacies in open debate:

- 2.a Speak with conviction, and argue not the person, but their words.
- 2.b Refrain misrepresentation, or exaggeration - if you do not know in your heart and soul what is fact, do not assume to speak as though you do.
- 2.c The supply of evidence and analysis, as provided to the claim, is greater than assumption or anecdotes.
- 2.d Refrain confusion of cause and effect, nor make claims therein, for we may never fully know the outcome or consequences of either.
- 2.e Do not assume the world to be binary. There are always more than two possibilities.
- 2.f Ignorance is not indicative of fact, or lack thereof.
- 2.g The burden of proof shall not be laid on those who would question, but those who would answer.
- 2.h Form the basis of your words with rational connections, and do not attempt to falsify them.
- 2.i Mere popularity in a claim is not the basis for fact.

## Navigating the Harbor Holistic

The Harbor Holistic is designed to provide comfort and sanctuary, and as such affords a wide range of amenities for our patrons. Each sector of the structure is named after the Intaki Devas of old, and referred to by their respective cardinal direction. For the purposes of this document, the cardinal directions are relative to the structure as seen from above, with the main docking ports on the 'South' side.

### Sector 'Kalki'

At the northern sector, our patrons may find a wide range of shops and dining areas fit for all manner of guests, regardless of their faith. This area also includes several mainstream vendors associated with the Caldari Megacorporations, and even an Aliastra supermarket. Delivery services are provided to quarters by 'Flashtail' enterprises and logistics.

## Sector 'Agni'

The western sector is home to all manner of entertainment, no matter how 'sinful' they may be considered. A variety of sports are conducted in this sector, and the sector even houses an 'Arena' for administration approved combat rituals. All areas in this sector are clearly marked and signify their religious implications for the patrons' discretion.

## Sector 'Budh'

The eastern sector is primarily home to the patrons' quarters and supplies a wide variety of faith-specific amenities. As such, quarters have been consolidated based on faith to ensure that patrons are well within the realm of their peers, as well as to provide better logistics for all applicable services therein.

## Sector 'Krish'

The southern sector is home to the Administration, security personnel, hanger access, and all manner of inner workings at the Harbor Holistic. Areas in this sector are often heavily restricted to authorized personnel, and patrons are asked to stay within the "Yellow" painted pathways when traversing this sector. As Sector Krish is often provides our patrons the first impression by nature of housing the docking facilities, 'Flashtail' enterprises offers a wide range of logistics services to make your transition into other sectors more pleasant.

## Sector 'Vremaja'

Named after Vremaja Idama, the central sector is home to the primary functions of the citadel in which all patrons may find areas to practice their respective faith. Amidst the towering spires of the Astrahus structure, patrons will find reasonable accommodations and easy access to required ritualistic items. Private meeting areas may be booked for civil discourse, or patrons may seek civil discourse at the central fountains around the statue of Vremaja Idama.
