MEMO – July 5, 2020

Our mission is to ensure that Marin County schools provide safe, equitable learning environments for all students. For this reason, we are requesting that SROs immediately be eliminated from schools, and that those funds be reallocated to trauma-informed and restorative supports.

Funding and support for SROs in our county are approved by multiple stakeholders, including:

- 1) School Boards and Superintendents*
- 2) City Councils*
- 3) The Marin County Board of Supervisors*

They need to hear from all of us as to why it is important to defund SROs in schools. This means showing up and speaking out at board meetings as well as directly contacting public officials. This contact sheet & meeting guide is a resource that you can use to engage with public officials around any issue – whether that be the call to eliminate SROs from Marin County schools or a separate concern. Our voices have power, and we must continue to hold people accountable while making our community a better place for all.
