

Dear Georgetown University Residential Student,

We are looking forward to providing a distinctive experience with you as our resident on-campus. In this message, we cover a number of important updates, including pre-arrival reminder, the move-in process and logistics, policies and expectations, and fall plans related and health and safety. In order to make your move-in to the Hilltop as smooth as possible, please familiarize yourself with the detailed instructions below.

Fall 2020 Move-In Days

In order to promote physical distancing, Fall 2020 Move-In will occur over a period of multiple days. There are several check-in dates for move-in to accommodate all community cohorts this semester in order to de-densify the campus, limit building access, and follow University COVID-19 testing protocols. Please reference your move-in day & time via the [Hoya Housing](#) portal. We will be unable to accommodate any early arrival or after hours requests.

1. If you are experiencing [symptoms](#) consistent with COVID-19 or are not feeling well, please do not come to campus. Email residentialliving@georgetown.edu for further information and instructions.
2. **We cannot accommodate special requests, early arrivals, or late arrivals.**
3. Everyone is required to wear a face covering while on campus.
4. Only students are permitted to enter residential buildings and assigned room to move in their belongings. **Parents, family members, and/or friends are not permitted to enter the residential buildings at any time.**
5. Pack light, and bring only what you need for the semester and what you can reasonably pack and carry home in a single trip. We recommend no more than two suitcases.
6. If the decision is made to close the physical campus, students will be expected to depart within 48 hours of being directed to do so. Each student will be responsible for either taking all personal belongings with them as they depart, coordinating and storing items, or shipping items home. Any items remaining will be discarded.
7. Bring cleaning supplies, hand sanitizer, and wipes.
8. Students should maintain a to-go bag, including prescription medications and eyeglasses, non-prescription medications, personal hygiene items, clothing for several days, face coverings, disinfecting wipes, and hand sanitizer.
9. Bring a dolly or other items to assist with your move-in as we do not have volunteers available. A limited number of carts will be available on a first-come basis. If you choose to use a cart, each individual is responsible for its cleaning before/after use.
10. Whenever possible, use stairs to assist with traffic flow and practice physical distancing (six feet or more between individuals).

Pre-Arrival to Georgetown

Immunization Requirements

All students who are on campus are required by DC Law and CDC recommendations to submit information regarding their immunization and/or tuberculosis screening status upon matriculation. The portal for submitting information is located at georgetown.studenthealthportal.com. For students approved to live on campus for the fall 2020 semester, a Spring 2021 Registration hold and \$100 fee may result if all requirements are not met by September 1, 2020. Issues or questions? GOCard

GOCard (Georgetown OneCard) is the official identification card of Georgetown University. All undergraduate students can now add their GOCard to Apple Wallet or Google Pay.

If you have not set up your GOCard Mobile Student ID, please:

- Review hardware requirements to see if your mobile device is compatible.
 - iPhone: iPhone 6, iPhone 6 Plus or later; iOS 12.2 or later
 - Apple Watch: Series 1 or later, and watchOS 5.2 or later
 - Android: version 5.0 or later

- [Enroll in DUO two-factor authentication](#), which is required to access your Mobile Student ID.
- Download the Transact EAccounts app from the [Apple](#) or [Android](#) app store and follow the in-app directions to set up your Mobile Student ID.

One Medical Information

We are working with [One Medical](#), a leading primary care provider network, to provide testing and a mobile application for daily self-attestations of symptoms. Please remember to download the One Medical app before you check-in to ensure a smooth testing process.

Storage Retrieval from Spring 2020

For those upperclass students who departed campus last spring 2019, it was a difficult experience and appreciate your understanding and support during a complex and quick transition. Any items packed by Hilldrup or managed through The Corp are available once you

return to campus. Whenever possible, items packed by Hilldrup are placed in your room prior to your arrival on campus.

Unauthorized Early Move-in

Students who arrive on campus without approval may not be accommodated until the approved move-in date. Any student who moves in but has not been approved may be charged a \$200 fine. Keys and GOCard access will be declined until your approved move-in date.

Arrival to Georgetown

Parking and Transportation

If arriving by car, park in the Southwest Quad garage, accessible via Canal Road. Parking is free for up to two hours. Vehicular traffic and street parking are not permitted on campus and cars found in violation will be ticketed. The use of oversized vehicles (box trucks, trailers, roof racks) is strongly discouraged. If parking on city streets, obey posted parking signs. Reservoir Road does not currently offer an entrance to the university. Students using a rideshare service should be dropped off at 37th and P Streets, NW. There will be no move-in services at this location, but is the best place to be dropped off and enter campus on foot. Please review the [Campus Map for Fall 2020 Move-in](#).

Check-In Process

Students should proceed to the Healey Family Student Center (HFSC) to check-in. **Only students are permitted to enter the Healey Family Student Center and your on campus apartment.** Family members are able to assist students in moving items while in an outdoor location. Face coverings and proper physical distance apply. If you wish to spend time with your family (e.g., a meal together), please do so before arriving on campus as there will not be time once you arrive.

During check-in, all students will:

- Conduct your first on-campus COVID-19 test with One Medical
- Sign up for the required additional tests
- Pick up your Georgetown University welcome kit and a meal
- Receive your key for your Fall 2020 room assignment

To aid with contactless move-in, you will receive a QR code by email. Those scheduled to move in by August 24, 2020 will receive their code during the week of August 17, 2020. Students scheduled to move in September 3-5 will receive their code on August 31, 2020. Either print out the code or have it readily accessible on your mobile device when you arrive.

Once you complete check in, you will proceed to your apartment to move in your items and start your quarantine period.

Quarantine Wraparound Services

During the self-quarantine period, students are required to stay in their assigned on campus apartment for the duration of their quarantine with the exception of trash disposal, laundry and emotional support animal or service animal care. When using the laundry room, only one person should be present in each space; face coverings and physical distancing are required. Students are not permitted to host any guests while themselves and/or apartment-mates are in quarantine. Students may leave the apartment for COVID-19 testing and medical appointments.

Virtual Activities during Quarantine
