

Jackbox Pick-a-Mug 2025 Giveaway Rules

- 1. Eligibility:** No purchase necessary to enter or win the Giveaway. The Jackbox Pick-a-Mug Giveaway promotion is open to legal residents of the 50 United States and D.C., who are at least eighteen (18) years of age as of Saturday, March 8th, 2025, except employees of Jackbox Games ("Sponsor") and its affiliates, partners, and advertising and promotion agencies, and anyone else involved in the development or execution of this Giveaway (collectively the foregoing entities are the "Giveaway Entities"), and the immediate families or household members of each. The contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited or restricted by law or regulations.
- 2. How to Enter:** Entrants should comment on the designated giveaway post, shared to @playjackboxgames on Instagram at approximately 11:00AM CST on March 8th, 2025. This comment should indicate whether the entrant prefers the Quiplash mug or Trivia Murder Party mug shared in the post. Entrants must also follow @playjackboxgames on Instagram through the entirety of the Promotion Period. To be eligible for the Giveaway, all entries must be posted between 11:00 AM CST on March 8th, 2025 to 11:00 AM CT on March 11th, 2025 ("Promotion Period"). If we do not receive a response from a winner by March 18th, 2025 via Instagram direct message, a new winner will be selected. Each participant ("Entrant") may enter only one (1) time during the Promotion Period.
- 3. Prize:** Eight (8) Grand Prizes: The Grand Prize winners will be awarded a Steam code for The Jackbox Party Pack 3 delivered electronically to the winner's email address or Instagram message. They will also receive either a Quiplash or Trivia Murder Party mug shipped to their physical mailing address, which will be inquired about when the winners are contacted. Winner may not resell Steam codes won as prizes as part of this giveaway. Prize is non-transferable and no substitution by winners or cash equivalent is allowed. Sponsor reserves the right to substitute prize for one of equal or greater value if the advertised prize becomes unavailable. Winner is solely responsible for the payment of all federal, state and local taxes and all other expenses or costs relating to the prize not expressly set forth above.
- 4. Selection of Winners:** Eight (8) Grand Prize winners will be selected at random from all eligible entries. In order to win, entrants comment on the designated giveaway post, shared to @playjackboxgames on Instagram at approximately 11:00AM CST on March 8th, 2025. This comment should include the entrant's preference for either the Quiplash or Trivia Murder Party mug. Entrants must also follow @playjackboxgames on Instagram through the entirety of the Promotion Period. Potential winners will be notified via Instagram direct message on or about March 12th, 2025 and will be given instructions on how to claim the prize. Potential winners must respond to the initial notification within 24 hours after delivery. Potential winners subsequently may be required to sign and return an affidavit of eligibility and liability release (and, where permitted, a publicity release) within an additional five-day period. Failure to comply with any requirements on a timely basis may result in disqualification and award of prize to an alternate winner. Odds of winning depend on the number of eligible entries received.
