Superintendent's Report – Matt Foster and Mike Moriarty were present to highlight a few items:

- Strategic Planning Process in the writing phase of the strategic plan. Plan is coming together nicely. Culture of engagement, high quality staff and staff retention, collaboration of the schools.
- Legislature AOE has a plan of 5 districts. Senate looking at a 6/3 plan, a modification of the AOE plan.
- Teacher negotiations in process.
- All schools passed their budgets.

Jay asked about school choice with the changes that the legislature is looking at? At this point, Matt has not heard that this is something that will be altered.

Walden – Anthony Fontana

Waterford – Chris Miller

- Spelling Bee had a great turnout.
- Annual donation of the Ice Out Tickets at Joe's Pond.
- Glow Dance was a success.
- Art teacher is retiring at the end of the year. Position has been posted.
- Looking to hire a clinical therapist. Working on a job description with HR. This is a shared position with the 3 schools.
- 8th Graders are taking a college visit to UVM.

Barnet – no report this time.

New Business

Continuous Improvement Plan Updates (Presentation – Des Hertz)

Des spoke on the Academic Achievement Goals with math and reading and shared the STAR assessments and student growth. Safe and Health school goal – looks at attendance (attendance tracking) and behaviors. Social/Emotional screener software will be rolled out at the schools. Currently in the pilot process with schools.

<u>Policy B20</u> - Personnel Recruitment, Selection, Appointment, And Background Checks (Recommended). An update to existing policy that outlines SU and District practices related to background checks for potential employees. (*Discussion/Possible adoption*)

One change is the SU will now pay for the background checks.

<u>Policy D24 (formerly D7)</u> - Special Education - Update to a required policy that outlines the SU responsibilities to meet the needs of students with disabilities. (*Discussion/Possible adoption*)

A **motion** to approve Policy B20 and Policy D24 by Dan Gingue and seconded by Dana Maxfield. Motion passed.

Principal Search Update for Barnet: Mike Moriarty noted that they currently have 4 to 5 applicants. A committee is being formed to sit on the hiring process. Will also do a staff survey to get a feel on what the staff is looking for in a principal. This will help guide the questions for the candidates. Currently Mike fills in at Barnet when Sam is out. Bobbie noted there has been a lot of positive feedback from staff with Sam.
