Abstract consists of the main problems, purpose, methods, findings, and conclusions. Abstracts written in English and Indonesian. Abstract is typed using single spacing and Cambria font size 10pt. Keywords need to be listed to describe the problem under research and made easy to search. Keywords can be single words or combinations of words and consist of 3-5 words.

Pendahuluan/Introduction (Cambria, 12pt)

The article structure contains (a) **Title**; (b) **Author(s) name, affiliation, and email address of corresponding author**; (c) **Abstract**; (d) **Keywords**; (e) **Introduction**; (f) **Method**; (g) **Results and Discussion**; (h) **Conclusion**; (i) **Acknowledgements (optional)**; (j) **Funding (optional)**; (k) **References**. Manuscripts should be typed in MS Word doc. format; using 11-pt Cambria font; space 1, before spacing 0 pt, and after spacing 0 pt, left, right, top, and bottom margins are 2,54 cm; on A4-sized paper.

The introduction includes the background of the issue or problem as well as the urgency and purpose of the research. It must support by the data or relevant literature in the same field and show the novelty of the research. It states the significant contribution of the research. All introductions should be presented in the forms of paragraphs, not pointers, and with the proportion of 15-20% of the whole article length. Citations is very emphasized to use a reference manager application such as **Mendeley**. This aims to make easy the reference writing in the end of article and avoid wrong citations.

The literature review represents the theoretical core of an article. In this section, we will discuss the purpose of a literature review. We will also consider how one should go about to find appropriate literature on which to base a literature review and how this information should be managed. Finally, we will answer four questions that first-time researchers often battle with when compiling a literature review.

This section presents the results and discussion of the research. The typeface used for this section is **Cambria size 11 pt**, line spacing 1 sp, before spacing 0 pt, and after spacing 0 pt. The research results can be supplemented with tables, picture, and graphs to illustrate the explanation. Don't make your table, pictures, and graph stand alone without description and interpretation. Tables, picture, and graphs also should be accompanied the annotation. This is the example format of table, pictures, and graph presented.

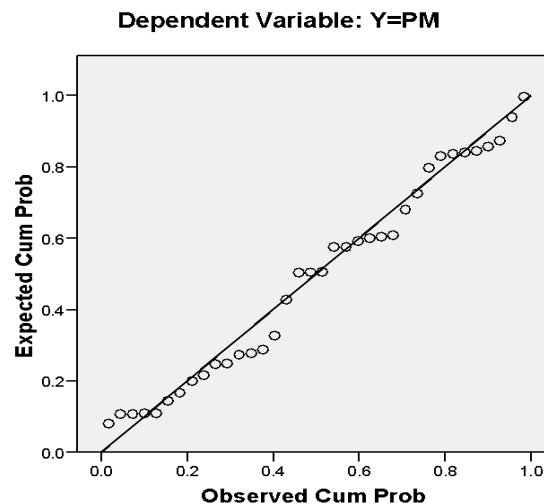


Figure 1. Normality test result

Kesimpulan/Conclusion (Cambria, 12pt)

Conclusions are written in one paragraph, which is a summary of the results and discussion.

Conclusions are answers to the research problems as well as an explanation research finding. Emphasize the novelty of invention. The typeface used for this section is **Cambria size 10pt**, line spacing 1 sp, before spacing 0 pt, and after spacing 0 pt.

Acknowledgements (optional)

Acknowledgments are used to give appreciation to those who played a role in the research/article. Acknowledgments can also be given to those who provide financial support. The typeface used for this section is **Cambria size 11 pt**, line spacing 1 sp, before spacing 0 pt, and after spacing 0 pt.

Daftar Rujukan/References (Cambria, 12pt)

This section contains references. Every source cited in the body of the article should appear in the list of references, and all sources appearing in the list of references should be cited in the body of the article. The references used are at least published in the last 5-10 years. Primary source references (journals, research reports including theses and dissertations) are at least 80% of the total references used. References are sorted alphabetically in ascending order (from the letters A to Z). Writing a bibliography must be accompanied by the url address of the reference used (if the source is online). The typeface for this section is **Cambria, size 10 pt**, line spacing 1sp, spacing after 6 pt. Writing should use a reference management application such as Mendeley, EndNote, Zotero, etc. The writing format used refers to the **APA 7th Edition (American Psychological Association)** format.
