#### Abstract

The abstract is written in two languages (English and Indonesian), each containing 150–250 words. It should explain the background, objectives, methods, main findings, conclusions, and contributions. Use Garamond font, 12 pt, single spacing, italic, and justified alignment.

**Keywords:** 3–6 keywords separated by commas.

It will be an added value if the sources come from reputable journals. (Font Garamond 12 pt, 1.5 spacing, justified).

# Literature Review or Theoretical Framework (Optional) (Font Garamond 14 pt, bold)

Contains a critical literature review and the theory used as an analytical tool. Authors may integrate it into the **Introduction** section if concise, but it is recommended to present it as a separate section. (Font Garamond 12 pt, 1.5 spacing, justified).

# Research Method (Font Garamond 14 pt, bold)

Explains the type of research (normative, empirical, socio-legal), approach (descriptive, critical, comparative), data sources (primary, secondary), analysis techniques, and data validity. Must be systematic and replicable. (Garamond 12 pt, 1.5 spacing, justified).

## Results and Discussion (Font Garamond 14 pt, bold)

Presents an introduction to the general findings and their relationship to the research focus. Subheadings are allowed. (Garamond 12 pt, 1.5 spacing, justified).

## Subheading 1 (Garamond 14 pt, bold, italic)

Specific findings are divided according to themes (subheading 1, subheading 2, etc.) with theoretical analysis included. Presents findings and critical analysis using the selected theory. Use tables or charts where necessary. Avoid data description without analysis. (Garamond 12 pt, 1.5 spacing, justified).

# Conclusion (Font Garamond 14 pt, bold)

Maximum 300 words. Presents the main conclusion (not a repetition), theoretical or practical implications, and policy or further research recommendations. (Garamond 12 pt, 1.5 spacing, justified).

#### References

Use APA Style, 7th edition. A minimum of 20 scholarly sources (80% from academic journals) is required. Include the DOI when available. Apply a 0.5-inch hanging indent. Interview references should not be included in the reference list. Example of reference (Garamond 12 pt, single spacing, justified):
