Cloudmallow Commission Terms and Conditions

I. Definitions

- a. **The Artist:** the individual producing the artwork/commission (CloudMallow, Arielle, Arielle Demot)
- b. The Client: the individual purchasing the artwork/commission
- c. **The Commission:** the artwork purchased by the client and created by the artist for the client for a specific fee

c.a. ROUGH SKETCH (full body)

A rough sketch with no colour, references required

c.b. BUST

Artwork of your character from the bust up, lined, coloured, and shaded, references required

c.c. HALFBODY/THIGH UP

Artwork of your character from the thighs up, lined, coloured, and shaded, references required

c.d FULL BODY

Artwork of your character from head to toe, lined, coloured, and shaded, references required

c.e CHARACTER PAGE

For the base price of 60 USD i will draw two full body poses of your character on a single page, rough lines, colour, and shade, any additional fees will apply if there are any extra poses, accessories, etc.

c.f COMICS

For a base price of 90 USD i will draw a comic page, simple background or background elements or block colours, rough line, colour, and shade, any additional fees will apply for complexity, panelling, and other such factors.

c.g CHARACTER DESIGN

For a base price of 100 USD i will design a character for you, either from scratch or given a theme or general idea

- d. Slot: A commission slot
- e. **The Commission Details:** everything regarding the commission and the involvement of both the artist and the client, these include but are not limited to-- the agreed price, a set deadline, the mode of payment, the specifics of the subject of the commission (i.e. the pose, color scheme, the character, etc.), and others.
- f. **Start of work:** the date upon which the artwork is begun
- g. Deadline: an agreed upon date upon which the finished product is to be delivered

♣ Flow of Work ♣

- The artist usually works according to the order of slots claimed.
- Unless a deadline is specified, the commission may take 1-2 weeks to complete
- The client is free to specify a canvas size, if they have a preference, otherwise the artist will work on their default size of 2000x2000 px or 1920x1080 px.
- The artist will provide first **a rough sketch**, at this stage the client is free to make corrections on anatomy, pose, outfit, background elements (if any).

This is followed by lineart, colour, and shading. Afterwards a watermarked version of the art will be sent to the client. The only correction that may be made at this stage is to colour.

REVISION concerning corrections: Any major corrections made may require additional fees

25% of every sale
