CONTEXT

The LA County Sheriff is not keeping us safe. #GoogleLASDGangs

Do you earn over \$385,000 a year? That's how much cities in LA County pay for one deputy. Overbilling is standard practice — Compton is suing the LASD for fraud. Over the past decade, the cost of a deputy has increased by 100%. What are cities getting in return? The largest Sheriff's department in the world spends billions of taxpayer dollars to surveil communities and incarcerate residents. It has 18 deputy gangs. LASD is responsible for nearly 300 in-custody deaths in the last 9 years. LASD's \$3.6 billion budget is larger than the budgets for Public Health (\$1.8 billion) and Affordable Housing and Homelessness (\$218 million) combined.

West Hollywood is #PayingMoreforLess

In February, the WeHo Public Safety Commission recommended the City Council direct \$3.6M out of the Sheriff's contract into social services or the hiring of unarmed security ambassadors. There are 60 Officers in the two square mile city, who soak up 20% of the annual budget. City staff are ignoring the Commission's recommendations and proposing to allocate LASD an additional \$290,000 this year plus \$500,000 just for Pride. The 2022-23 proposed budget allocates four times more to the Sheriff's department than to social services. For one deputy, WeHo could have three mental health or social service workers, or 11 unarmed security ambassadors.

TALKING POINTS

- We are disappointed to see that this year's proposed contract is once again an overinvestment in the sheriff's department and an underinvestment in care.
- Last year, 60 deputies cost \$20.4 million. The cost per deputy rose by over 100% in the last decade. What are cities getting in return? The crimes the department solved last year were 2 out of 249 stolen phones.
- The Sheriff has not been prevented from hiring more deputies to serve Contract Cities. It hired 1,900 more deputies last year which can be assigned to WeHo.
- The sheriff is not being defunded. In fact, LASD's budget increased from \$3.5 to \$3.6B this year.
- WeHo's budget is a reflection of the city's leadership. The proposed Sheriff's budget is four times the budget for social services. Instead of re-allocating funds from the department, LASD received an additional \$290,000 plus \$500,000 just for Pride weekend.
- For the cost of one LASD deputy, West Hollywood could employ three clinical mental health workers.
- Reallocating money from the deadliest, most well funded law enforcement agency in the world is a popular mandate.

- This is an issue of fiscal responsibility. When asked to provide line by line accounting of how
 contract costs are being spent by the department the Sheriff's department showed up with a
 blurry spreadsheet of general expenditures.
- Cell phone theft in West Hollywood is a real thing and can't be ignored but what we've seen is
 that the Sheriff's department is not the agency to address this issue. Their 'undercover units'
 retrieved TWO out of over 400 cell phones stolen in the last year. Investing in a public
 awareness campaign about securing one's belongings is a more worthwhile investment than
 increasing funding for a department that does next to nothing to solve this issue.
- Clearly the city of West Hollywood believes in challenging the systems of mass incarceration. I
 support the city investing in pretrial services and alternatives to incarceration and believe that
 these values should also be reflected in their contract with LASD.
