



CONDITIONS OF PLAY

Competition rounds will be over four (4) weeks with Finals on the 5th week. The top team from each venue will play Semi-Final and Final.

The final will be played on the new multi-million dollar undercover green at Wentworthville Leagues and will be live streamed on Facebook.

We will also have live commentary from former Australian representatives, Scott Caundle and Cameron Curtis.

The four venues are Castle Hill Bowling Club, North Ryde RSL, Dundas Sports Club, NBC Sports Club & Finals at Wentworthville Leagues Club.

Teams of three (men, women or mixed) and the first 14 teams at each venue will be accepted (maximum total of 56 teams).

THE FOLLOWING RULES APPLY

- □ There can be only 2-registered bowlers (before the start of competition) per team and 1 non-registered bowler; you may have 2 non-registered bowlers.
- 2 x 5 ends sets plus one end tiebreak if required 4 point per win, 0 point for a loss. If teams are equal in points margin for & against will come into play.
- □ One (1) Power play end per team, per each set (Double Points scored that end)
- One (1) reserve per team allowed each night (but only two registered bowlers).
- □ Time 6.00pm start
- □ No dead-ends with jack re-spotted on the 2-metre mark
- Dress: Mufti (casual) uniform to be worn.
- **Entry fee:** \$120 per team which covers the green fees over the entire competition
