

We recognize that privacy of your personal information is important. Here is information on what types of personal information we receive and collect when you use visit, and how we safeguard your information. We never sell your personal information to third parties. We are committed to protecting your privacy. This privacy policy applies to our software applications (browser add-ons, desktop apps).

## **Personal Information**

We do not collect personal information. Our server collects statistical data as every server - IP, OS type, Browser type, language etc. We use the server statistics only for statistical purposes. If you purchase our product(s) or service(s) - we will use your personal information only for communication purposes.

## **Data usage**

The information collected by the organisation is used for various purposes, including to: provide and maintain the website, improve and personalise the website, understand user behaviour, develop new products and services, communicate with users for customer service, marketing and promotional purposes, send emails, and prevent fraud.

## **Ads Partners Privacy Policies**

Advertising Partners Privacy Policies are designed to provide transparency and control over how data collected from the website is used by third-party advertising partners.

Third-party ad servers or ad networks use technologies like cookies, JavaScript, or Web Beacons that are used in their respective advertisements and links that appear on Auto Refresh Extension, which are sent directly to users' browsers. They automatically receive your IP address when this occurs. These technologies are used to measure the effectiveness of their advertising campaigns and/or to personalise the advertising content that you see on websites that you visit.

Note that Auto Refresh Extension has no access to or control over these cookies that are used by third-party advertisers.

## **Log Files**

The log files collected by the website contain information about IP addresses, access dates and times, and visited pages. The website does not collect personal information from log files and uses the information only for analysis, administration, tracking, and demographic purposes. The log files are protected with encryption and security measures are in place to prevent loss, misuse, or alteration of the information. The

privacy policy regarding log files may be updated at any time and the updated policy will be posted on the website.

### **Third Party Privacy Policies**

The Privacy Policy of the Auto Refresh Extension does not cover other advertisers or websites and users are advised to check their respective Privacy Policies. Cookies can be disabled through individual browser options. The extension may monetize user activity on visited websites to sustain itself. Information on cookie management for specific browsers can be found on their respective websites.

### **California Consumer Privacy Act (CCPA)**

Under the CCPA, among other rights, California consumers have the right to:

Request that a business that collects a consumer's personal data disclose the categories and specific pieces of personal data that a business has collected about consumers.

Request that a business delete any personal data about the consumer that a business has collected.

Request that a business that sells a consumer's personal data, not sell the consumer's personal data.

### **Children's Information**

The Auto Refresh Extension places importance on protecting children while they use the internet and encourages parents and guardians to monitor their online activity. The extension does not knowingly collect any personal information from children under the age of 13.
