BE IT RESOLVED, MSBA URGES THE LEGISLATURE TO (please clearly and concisely state the action you would like the legislature to take): Immediately provide full funding (\$169 per pupil in State Aid, and the ability to levy local taxpayers for an additional \$91 per pupil) to all public school districts currently on the waitlist for QComp (Alternative Teacher Professional Pay System). In future years, provide full funding to all school districts that may apply to this program.

DESCRIBE THE PROBLEM:

Since the 2016-17 school year, the Minnesota Department of Education has not approved new school districts to receive revenue. Currently there are 27 school districts on the wait list to receive this critical categorical funding in our schools. State funding for QComp has been capped at a finite amount for an extended period of time.. There is currently an arbitrary 'cut off line' whereby districts that applied sooner than other districts received funding, and those, like Shakopee Public Schools, and the 26 additional districts, that applied later only to end up below the arbitrary cut off line and receive no funding.

EXPLAIN WHY THIS IS A PROBLEM:

Without this funding, school districts are having a hard time staying competitive with other comparable districts. Districts on this waitlist are not able to support the development of their teachers like other districts with this funding which is resulting in losing them to other districts. This results in a reduction of money available to pay our teachers as they progress down their career path. Ultimately, teachers leave the district for more pay elsewhere or just leave the profession altogether.

The lack of funding for this program has made it inequitable. In a time where teachers are leaving the profession, we need to put forth the funding to keep teachers in the profession.

In Shakopee, if we would have received this funding since our application was submitted 8 years ago, our contract negotiations with the local Shakopee Education Association would have been completed more swiftly, specifically with the last contract. If Shakopee would have received this fund for the past 8 years, it would have provided approximately \$14 million in additional funding to support our teachers.
