If you have made a purchase from Walmart and you are not satisfied with the item, you may be wondering what your options are. Is Walmart accepting returns? Can you return to Walmart without a receipt? What does the **Walmart return without receipt** policy mean?

Walmart Return Without Receipt Policy: Overview

If you recently purchased a product from Walmart, then you can easily return it to them, even if you lost the receipt. This is conducted under the **Walmart return policy without receipt**. This is similar to **Target return without receipt** policy.

If you wish to return to product to Walmart, you only need to follow a few simple steps, which I have explained below.

However, before you do so, ensure that you are carrying a photo ID to verify your identity. Therefore, you cannot return products to Walmart through the mail.

Take the item you wish to return to Walmart and go to your nearest Walmart store. However, it's recommended that you go back to the same store you bought it from.

Just go to the Returns Counter, and present them your item, explaining why you wish to return it.

Walmart will check its databases for more information to confirm the sale of the product. Once confirmed, they will then provide you with a **Walmart Gift card**. Using this card, you

won't get a refund. However, you can buy any other product with the same price tag as the previous product that you returned (minus taxes).

However, if the price of the product is under \$10, then you will get an instant cashback.

In general, you have up to 90 days to return an item as per the **Walmart return without receipt** policy. However, there are some exceptions for certain items. For example, electronics and digital items can only be returned within 30 days.

In addition, you are only eligible to return products to them three times in six months. You will be barred from exceeding the limit.

While this policy is applicable to most Walmart products, some products are excluded from this list. You can learn more about them below.

Walmart Return Without Receipt: Things You Cannot Return

There are various things that you cannot return to Walmart under the **Walmart Return** without Receipt policy. Some of these products are similar to what's not accepted under and Jack Return Policy:

1. Trading Cards

Let's face it - most of us have spent hundreds of dollars buying **Pokemon trading card** packets to get that one rare *Charizard* or *Pikachu* card.

Since you get a random number of cards of any rarity from the packets you open, you might end up finding a valuable rare card that you might have been looking for. But what about all the other common cards that you already have in your collection?

Many people would want to return packets of trading cards because they got copies of cards they already have. Since you have to open the packet to reveal its contents and test out your luck, no one else would like to take it if they already found out the packet to be opened, with all of the cards being common cards that they already have.

2. Opened Or Defective Collectibles

Similar to the example of trading cards above, collectibles that have already been opened cannot be returned to Walmart. This is because most people would like to return the collectibles that they have purchased once it gets broken. Otherwise, there doesn't seem to be any reason to return the *Naruto action figure* people buy, right?

Walmart won't take back such items because the value of collectibles lies in their condition. Therefore, they are the most valuable when they are inside a sealed package. Once the packet is opened, its value diminishes.

This is why Walmart won't take back collectibles as per the **Walmart Return without** receipt policy:

- Action figures
- Barbie dolls
- Porcelain dolls
- Die-cast cars
- Toys

3. Walmart Gift Cards

If you shop extensively at Walmart or make some pretty expensive purchases, they may procure you a gift card. Most of these gift cards are provided to customers for free and have no real value.

Therefore, you cannot ask for refunds on returning free gift cards provided by Walmart. This is because they expect you to use that gift card and get the rewards, not return them.

4. Medical Equipment

Most medical equipment cannot be returned to Walmart under the Walmart Return without Receipt policy. This is because medical equipment, once used, has a high chance of carrying germs with them.

For example, if you use an injection syringe, it is typically thrown away. If given back to Walmart, then they will not take it back. This is because used syringes might still contain harmful disease-carrying germs of the previous user. Used syringes effectively raise the chances of people suffering from HIV and AIDS.

5. Firearms And Ammunition

While the gun laws in the USA are in serious need of revision, you can buy firearms in the US as long as you have a license to buy them. However, due to its somewhat lax yet strict laws, you cannot return them once purchased.

6. Used Tires

Tires lose their value when they are used. If your tire is already a used one, it can cause safety hazards if used again. This is why Walmart doesn't accept used tires under their return without receipt policy. However, if the tire was never used (preferably still sealed), then it an be returned.

7. Digital Downloads

In addition to the aforementioned products above, you cannot return digital downloads at Walmart as well. This is exactly the same as **Carter's Return Policy**.

This is because most digital downloads are not super expensive and are more or less infinitely usable. For example, if you download a video game for \$60 and then return it back after playing the game and finishing it. Here, you have already consumed the product in its entirety, but it still can be replayed as many times as you want.

8. SIM Cards

Since SIM cards are registered to your name, they are typically non-transferable or can be returned. Moreover, to actually do so, you need to do so from the cellular network provider themselves. Walmart only sells them and helps you get a SIM card registered in your name.

9. Groceries And Fresh Produce

All groceries and fresh produce like flowers, meat products, dairy products, and other forms of edibles all have a "*Freshness Rating*" rated by Walmart. This rating shows how fresh the edible is before being termed unfit for consumption.

Similar to **Trader Joe's Retuien Policy**, when you return such items, Walmart representatives will check whether they are fresh or not using their checking system. If they are still certified fresh, they will be accepted. Therefore, it's recommended to return such products in under a day or two to increase your chances of returns.

Conclusion

The **Walmart return without receipt policy** is that you can return most items within 90 days for a refund or exchange. However, there are some restrictions.

For example, electronics and digital items can only be given back within 30 days. If you do not have a receipt, Walmart may be able to look up your purchase in their system using your credit card.
