New Alma UI

Adoption of the new Alma UI continues on across institutions, towards the Jan 1 2018 cutover. In general, the new Alma UI is working well.

Though, we have seen (and reported) a few cases where the new Alma UI has introduced new issues. Please continue reporting any such cases via SF, or post to wactclc-alma listserv with reports if you aren't sure.

SF Cases opened on the new UI by our institutions include:

- 484583, Yakima (problems saving Fine/Fee Profiles via the new UI)
- 468257, Olympic (problems associating holding to POL)
- 477085, Seattle (problems viewing items from within course reserves reading list)
- 472252, Seattle (warning message in MDEditor about leader 18)

If you are aware of any other new Alma UI Salesforce cases not listed above, please email Wade with the case #.

IMPORTANT NOTE: As of Jan 1, 2018, the classic Alma UI will no longer be available, only the new Alma UI.

Advanced Searches – Alma Classic UI vs New UI

The logic of how advanced searches are built changed in Alma's new UI from Alma's classic UI. As a result, saved advanced search queries (logical sets) built in the classic UI cannot be edited in the new UI (and vice versa). These queries must be recreated in the new UI.

Community Zone activation vs Manual Creation of electronic collections

We discussed some specific collections and instances where creation of a local electronic collection offers better discovery for patrons than activating the equivalent community zone collection.

Specific collections mentioned as subjects of such local electronic collections include:

- EBSCO ebooks
- Films on Demand
- Kanopy
- Gale ebooks
- PQ Ebook Central
- SWANK
- Salem Press Books
- OVID
- Books 24x7

Creation of a local electronic collection requires obtaining MARC records for the collection that contain the relevant resource URLs in an 856 field.

Records for some collections are available through WorldShare Collection Management

Wade will create a document to share via wactclc.org that describes the creation of a local electronic collection, and some of the steps involved, including obtaining MARC records via WorldShare Collection Management.

Contributing Electronic Collections to the Community Zone

This topic also came up as part of the general electronic collections discussion.

It is possible to contribute electronic collections to the community zone, subject to Ex Libris acceptance based on a series of consideration.

Though, I (Wade) was *wrong* on a *crucial* point. We *cannot* create for community zone submission an electronic collection of vendor records, such as we would use to create a local electronic collection for ourselves, based on reasons of accuracy, etc. (It was a great idea, though:)

And, in hindsight, this seems obvious. Such vendor records would be subject to copyright, and are not ours for distribution to others.

The types of electronic collections that you *can* submit to the community zone would include electronic collections representing things like special collections (say, online versions of an author's works bequeathed to the library), for which the library has publication rights. Or databases (say, of historic weather data), which represents intellectual property to which the library or institution has publication rights.

Upcoming

Alma November 2017 Release

Alma November 2017 release is coming this weekend (11/4, 11/5). Release notes available at:

Most interesting new features for us include:

- View Only Catalog, Repository, and Acquisitions Administrator Roles As was added in the <u>September release</u> for Fulfillment and User Management, a read-only role parameter was added for the Catalog, Repository, and Acquisitions Administrator roles. A user who has this role with the role parameter enabled can view configuration options but not edit them. This feature exists in the new UI only.
- New Electronic Collections Added to the Alma CKB
- Move PO Lines and/or Licenses from an Existing Electronic Collection to a New Electronic Collection – Alma now provides the capability to move PO lines and/or licenses from the existing electronic collection to a new replacement electronic collection.

Discussion about ELUNA attendance

We briefly discussed ELUNA, and generally agreed that attendance at ELUNA by institutional leads and functional leads is highly encouraged, as is submission of presentation proposals, as applicable.
