1. Balvicar Street Play Area

- KM updated the working group on current status of the project. Initial consultation work has been undertaken by partners at Glasgow University (GU), with a parents / carers survey made available online. The second consultation activity undertaken was visits to local Primary Schools. KM advised that a procurement timescale is not confirmed, but will likely be later in 24 for construction works
- KM advised a follow-up piece of consultation will be undertaken by NRS and will follow on from the work undertaken by GU.
- A question was raised regarding the ongoing Development Plan and ensuring the final design proposals align with the Dev Plan and vice-versa. KM advised this would be kept in mind throughout.
- KM advised that funds for the play area development have been sourced from Scot Gov play renewal and Local Parks and Open Spaces Fund. Developer Contributions would continue to be considered.
- It was raised that the working group should consider the diversity of the working group, including consulting with the relevant Community Councils on how the group functions.

2. Development Plan Update

- Lucy Gillie advised that the park has been zoned based on usage and activities.

3. Parks Lighting
