Terms and Conditions

1. The Vietnamese Association, Toronto (VAT) will not accept any responsibility for any loss or damage caused to the Venu Event Space facility by the exhibit or the exhibitor, nor will it be held liable for any personal injury caused by the exhibit or exhibitor. Use of the facility is conditional upon the exhibitor accepting full responsibility for ALL damages caused by the exhibit or the exhibitor. VAT is not responsible for lost or damaged items left or stored at the exhibit booths.
2. Each exhibit booth will be provided table(s) and chairs according to the requested level. Additional tables and chairs can be ordered for an additional cost. Please indicate additional requirements on the application.
3. It is the exhibitors’ responsibility to keep the exhibit space and booths safe, clean and free of damage. Exhibitors are not permitted to move from the assigned location or remove tables and/or chairs not assigned to them.
4. No signage or other articles are to be fastened to wall brackets or other electrical fixtures. The use of double-sided tape (rubber backing type), scotch tape, thumbtacks, nails, screws bolts, hand spikes or any tool or material which could damage the floor or walls is prohibited. Only masking tape or a material that could be easily removed without damage to walls or surfaces is permitted to be used for affixing signs, banners, etc.
No adhesive backed (stick-on) decals or similar promotional items are permitted in the halls or exhibit areas. No signage is to obstruct fire exit signs or doors.
5. All exhibitors are required to show entrance tickets in order to enter the Tet Festival. Those who do not have tickets must provide the security staff with their driver’s license(s) or \$30 per person, which will be returned to them upon exiting PRIOR to the start of the Festival.
6. **Exhibitors may only reserve booths after the application and full payment have been received**

by VAT. Completed applications, after full payment, will be processed on a first-come, first-served basis. Deadline for the exhibit application is December 31, 2025. Applications received after this date will not be guaranteed exhibit space.

7. Except for the Title Sponsor, **there is no exclusivity for exhibitors.**
8. All booth applications are subject to approval by the Review Committee who reserves the right to accept or decline any application without cause. If not accepted, the payment will be returned in full to the applicant.
