

**FULL PAPER TEMPLATE FOR
SIXTH CONGRESS OF MACEDONIAN GEOGRAPHERS WITH
INTERNATIONAL PARTICIPATION**

General:

A manuscript must be original, and not already published or given for publication in another journal, report, or any other form of public publication. The manuscript should be made in the text-processor MS Word 2007 or newer. **The file name should title Surname of the first author, first three words form the Manuscript Title.**

The maximum size of the manuscript should be up to 15 pages, including all attachments. The use of standard abbreviations is acceptable. Linguistic accuracy is the responsibility of the authors. The use of footnotes should be avoided or explained in the main part of the text in brackets. Data and values are to be displayed in the metric system. A manuscript that is submitted for publication in Proceedings must be prepared according to the technical criteria detailed below.

Technical details:

The manuscript main text should be written in English, using Times New Roman, Font 12, Spacing 1,15. A font size between 10 pt. and 12 pt. will be used, depending on the section. When citing or referencing foreign literature or authors, “original” wildcards and letters inherent in that language can be used. In the manuscript, citations and references must be used correctly and fully listed at the end of the paper in the section Reference.

Page Setup: A4 paper size, orientation portrait, margins left/right 2,5 cm, top 2,5 cm, bottom 2,5 cm, header/footer 1,25 cm. Alignment Justify from both sides. The manuscript should contain the following sections:

- Title of paper;
- Name of the author and co-authors and basic information (institution, address, e-mail);
- Abstract;
- Key words;
- Introduction;
- Data and Methods;
- Results;
- Discussion;
- Conclusion;
- Acknowledgments (if there is);
- References;

Authors and affiliation:

One row below the title of the manuscript should be the written author (and co-authors) of the manuscript, with their affiliation and corresponding author e-mail.

- Author's name and surname;

- Author's full affiliation address (e.g., Institute for Geography, Faculty of Natural Science and Mathematics, Ss. Cyril and Methodius University in Skopje, 1000 Skopje, North Macedonia);
- Author's e-mail address;

Figures and Tables:

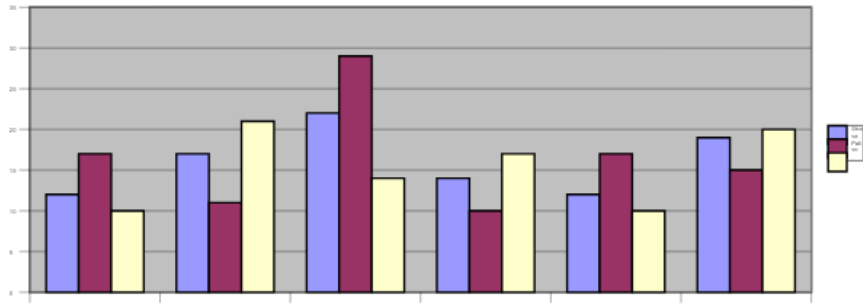


Figure 1. Figure description (Times New Roman, 10 pt., centered).

A manuscript can contain one or more figures and illustrations (photos, graphs, maps, or charts). Figures and illustrations must be made in high quality (minimum of 300 dpi) in JPG or PNF. Format, numbered with a figure caption under the figure (e.g., Figure 1. Title of figure, author:, Figure 2. Title of figure, author:, and etc.). At the end of the figure caption, the full stop is placed. Captions of the figures must be concise, centered at 10 pt. Maps and photos must be illustrated in color.

Each table should be serially numbered with Arabic numerals, and a table caption should be placed above the table. Center alignment, font size 10 pt. (not smaller) to make tables fit the page size. Tables should not exceed the margins of the page. Central positioning of each table.

Formulas / equations:

Formulas and equations should be typewritten in the Microsoft Equation Editor or similar software. Subscripts and superscripts should be clear. After the equation, it is necessary to enter the explanations for each symbol of the equation individually.

Citation and References:

In the manuscript, citations and references must be used correctly and fully listed at the end of the paper in the section. When citing quotations, the citation is given elsewhere in the manuscript, e.g., according to Markoski (2011), or on the end of the cited sentence (Markoski, 2011), or the author's surname is followed by the year of publication and page number (Markoski, 2011, p. 24).

If the cited work is by several authors, then in citation-reference the name of the first author and the abbreviation et al. are given, (e.g., Andonovski et al., 1998). If the same author has several papers published in one year, they are cited with small alphabets: 1999a, 1999b, 1999c, etc., corresponding to their order in the references at the end.

If sources or works from the Internet are used, they must be referenced as electronic publications with all the previously mentioned elements (name of author, year of publication, etc.). If a website is used as a source of information, the web address should be referenced, and when the site is set, e.g., (<https://www.ig.pmf.ukim.edu.mk/>), (Accessed, 21.02.2023)

All authors, i.e., citations required, must be presented in the references at the end of the manuscript, and vice versa, all references indicated at the end of the manuscript must be cited in the paper.

At the end of the paper, references are presented, with a font size of 11 pt. Used references should be presented in the same language and font as the original and arranged in alphabetical order. Referencing is in standard scientific form: author's surname, name

initial(s), followed by year of publication, title of the paper, magazine, or medium in which it was published, publisher, place of publication, and page numbers.

Remark: If all authors are from the same affiliation, it is not necessary to use numbering/superscript for each author's name.
