TITLE	Chapter 8 Amendment - Judicial Stipends

BACKGROUND

This senate bill is to add into section 6 Chapter 8 of the ASUCR bylaws the stipends for the ASUCR Associate Justices.

Background Prior to this senate bill the Associate Justice position was an unpaid role. Due to the complete restructuring of the Judicial Council as well as a large increase in responsibilities over the last few years it is now fit for all ASUCR Justice positions to receive their own stipends. During the 2022-2023 school year it was voted by the Finance Committee that these Associate Justice positions as well as the Vice Chief Justice position would receive temporary stipends for the remainder of the school year, and would potentially be added into the bylaws to be made permanent after assessing the performance of these aforementioned positions at the end of the year.

THE ASUCR SENATE HEREBY AMENDS CHAPTER 8 OF THE ASUCR BYLAWS AS FOLLOWS, Chapter VIII

1. **Section 6.**
2. Stipend Levels
3. (a) The "maximum stipend levels", as established by the Senate, shall be the base value upon which all stipends will be determined;
4. (b) The actual dollar amount paid to each stipend position shall be determined by the appropriate maximum stipend level as provided for in subsection (c) and (d) hereof, with the stipend being the percentage of the maximum level.

5. (c) The following shall be the stipend levels for the Officers of the Associated Students, based on the nine thousand nine hundred dollar (\$9,900) maximum level;
