CONTRIBUTIONS

- i. The UNO declared human rights in 1948 so colonization was against human rights. UNO propagated equality, freedom and democracy.
- ii. The UNO formed the trusteeship council responsible for preparing colonies for their self determination. The German colonies after 1945 kept under this council. E.g. of the colonies were Tanganyika, Togo, Namibia and Cameroon.
- iii. The UNO general assembly pressurized the colonial powers to grant independence to their colonies especially the socialist powers.
- iv. Some African nationalists used the UNO to address issues of decolonization
- v. UNO acted as a forum for decolonization campaigns
- vi. UNO introduced Veto power which was used by the super powers USSR (socialist super power) and USA (capitalist power) to support decolonization in Africa and Asia.
- vii. UNO supported pan Africanism morally and materially.
- viii. UNO included the principle of self determination in its charter
- ix. UNO provided moral and material supports to African countries

RESPONSIBILITY OF UNO TOWARDS PROSPERITY OF AFRICA TODAY

- i. To work out neo-colonialism in Africa
- ii. To end up oppressive policies made by developed nations
- iii. Resolution of conflicts and peace keeping
- iv. Provision of soft loans to African countries
- v. Environmental conservation
- vi. Promotion of human rights and accountability among leaders
