  - Looked over Mr. Berube's Town Hall Motion Committee approved unanimously so it will be coming to Council soon

  - Discussed the schedule and tried to fit classes in that students want to take
- Student Life Committee [Locky McCann ('23)]
  - Had a white board in the Atrium asking students about thoughts on the Assassin Motion
  - Most students thought that Gun Violence Protests and Assassin can co-exist
- Secretary [Anna Healey ('24)]:
  - Senior and Junior alternates may vote

#### 3. Examing Equity Committee Elections

Kai Doron and Vidushi Sharma are the new Examining Equity Committee Council reps.

- 4. <u>Squirtfest Opposition Motion 2022-2023</u> [brought by Mack Levy ('23) (on behalf of Mr. Murphy)]
  - Discussion Cont. from last week (New Speaker's List)
    - Why are we taking a stance over something that we do not have jurisdiction over?

- School shootings in this country are a terrible thing
- A precedent has already been sent- the school has already banned the game from school property
- As a Senior Class Committee member, [Speaker] can confidently say that this motion will not change anything
- The student body will not be happy if they hear that Council has spent three weeks working towards something that they do not have jurisdiction over and are trying to take away another Hanover tradition
- There is a mental leap from shooting water at someone vs a bullet
- Most seniors are 18 by the time they play the game
  - They have the right to choose to play the game or not
  - It is not a school sanctioned game
  - Council should not have a say over what students do in their free time
- Council has put itself on a pedestal claiming that what we think is right and by doing so we are forgetting our constituents
- No Council member who is going to play Assassin should vote in favor of this motion
  - It would be incredibly hypocritical to do so
- Council has power in creating discussion in our school
  - We would not be jumping on the bandwagon of staff and administration but would be opening a discussion for the students
  - We are establishing the precedent of hopefully ending Assassin which is different than the one that the administration set
  - [Speaker] does not plan on playing Assassin
  - No one has claimed that Assassin causes gun violence, it is instead hypocritical to play Assassin and work to stop gun violence
- Doesn't matter who is for or against this motion, it is wasting Council's time
  - Everyone is repeating their opinions
  - Because this motion will have no effect on the student body we need to close debate and vote on this motion
- Personally, the [speaker] had to jump into a ditch with her daughter to move out of the way of a car with a student playing Assassin in it
  - We value equity at our school
    - We have privilege in the Upper Valley and it is not as risky for us to play games like this but it is risky for students who play it in other cities

- If we are truly checking our privilege we should not participate in something that other students can not participate in safely
- Though this isn't within Council or the school's jurisdiction Council should issue a statement because if something were to happen, it would most likely reflect badly on our entire school

#### \*Point of Information\*

- Explaining abstentions used to be in practice in Council but that is not in accordance with Robert's Rules so we stopped allowing that.
- Can speaker's choose to explain their abstentions?

#### \*Point of Information\*

• [Speaker] was under the impression that abstentions were to only be used when the voter missed a meeting or was biased in some way

#### \*Point of Information\*

• [Speaker] believed that an abstention vote was okay to be used if one didn't think that there had been enough debate on a motion

#### Motion Fails (Roll Call Voting Record)

- I move to refer this motion to a referendum. [brought by Mr. Berube (staff)]
  - Seconded by Shayna Rockmore
  - Authorship Speech:
    - In our <u>Bylaws</u> it states that Council can refer any motion to be voted on by the school body
    - It would be voted on within 3 days and the vote would be run by OEC

- It would be good to turn this vote over to the people, our school and community
- Question Session:
  - How will this work with Thanksgiving break coming up?
    - The voting would stay open for 1 week
  - Who would be allowed to vote?
    - Students and staff
- Debate:
  - [Speaker] feels that it is time to stop prolonging this motion
    - It is clear that this motion is not what Council or what seniors and other students want
    - Dumping this on OEC would not be fair
  - [Speaker] is unsure of whether or not this referendum is valid as
    Council already voted on the motion

#### \*Point of Information\*

- Referendums can only be made after a motion has been passed or failed by Council
  - This referendum is in line with the motions intent as it would spark discussion which was the motion's goal
  - Opening up this motion to the public is unnecessary because the senior class already said that they would not be changing their game based on any Council decision

#### \*Point of Information\*

- The Bylaw Language regarding referendums is now up on the projector.
  - The original motion was requesting Council's opinion and it would not make sense to ask the school "What would you like Council's opinion on this motion to be?"
    - Getting the school's opinions would be great but a new motion would need to be brought to make it make more sense
  - This is an unnecessary burden on OEC
    - Majority of staff were voting in favor of this motion while majority of students were voting against this motion which would most likely be representative of what the entire school's opinions would be
  - This is a great idea as it would allow the school to directly give their opinions and make the decision for themselves

## \*Point of Inquiry\*

- How many people are left on the speaker's list?
  - o 6 people

#### **Debate Closes**

#### \*Point of Inquiry\*

- What would the language of the referendum be?
  - The students and staff would be voting for Council to make a statement about Assassin
  - The language would match the original language of the motion

## \*Point of Inquiry\*

• This motion requires 2/3rds to pass.

#### \*Point of Information\*

- [Speaker] missed vote so can we please revote?
  - Yes

  - o 9 voted for the referendum while 21 voted against a referendum
