**REGARDING ANDREW CUOMO'S NURSING HOME SCANDAL, THE
NYS BOARD OF TRUSTEES ISSUES A WARRANT FOR THE ARREST
OF ANDREW CUOMO FOR CRIMINALLY NEGLIGENT HOMICIDE.**

ALBANY, NY

The New York State Board of Trustee (NYBOT) issues a [warrant for the arrest of Andrew Cuomo](#) for CRIMINALLY NEGLIGENT HOMICIDE a crime under New York Penal Law § 125.10 on grounds of the following, admissible hearsay—publicly-available—government documents.

These documents constitute probable cause and affirmation of facts sufficient for an arrest warrant, as required by, the Fourth Amendment.

The two elements for probable cause and affirmation are:

1. As Governor, Mr. Cuomo *ordered* nursing homes to commit negligence. (Order given March 25, 2020) ([LINK](#))
2. The NYS Health Department *acknowledges* resulting COVID-19 fatalities. (Report issued July 6, 2020) ([LINK](#))

It is not the job of the health department to determine legal responsibility for the fatalities it acknowledges. That is the job of a jury.

NYBOT acknowledges that probable cause exists to start that process.

NYBOT's warrant provides a basis for courts to issue court-issued warrants and guidance to prosecutors and law enforcement to seek such warrants.

Additionally, this Warrant commands law enforcement to pursue a court-issued warrant to make the arrest, or to stand down, so that civilians

can make citizen's arrest by themselves using this warrant as legal protection.

The NYS Board of Trustees asks that all town and city councils and county legislatures [take up emergency resolutions](#) to affirm the facts of the warrant and confirm the Board of Trustees at the local level.

About the New York State Board of Trustees:

The New York State Board of Trustees was created using the plenary powers of the people, which is an exercise of our rights, under the Tenth Amendment. Plenary powers are reserved to the people. The Tenth Amendment is operational in New York through the incorporation doctrine.

Notice of its creation was given to the NYS Police June 3, 2020. Additional notice was given to the Albany Sheriff's Office October 30, 2020. NYBOT served written notice to the Governor's Mansion November 13, 2020.

This press release constitutes additional notice to the public and to all other government entities. It serves as a basis for their lawful action against Mr. Cuomo, and serves as a basis for cooperation going forward.

It is time that New Yorkers were united in an effort to remove from office a homicidal governor who can't seem to leave office as Eliot Spitzer had the sense to do. NYBOT is the leading and only institution pursuing the lawful arrest of Andrew Cuomo and asks for the active support of the people of New York to restore self-government.

In its founding [Writ of Regime Change](#), the Board of Trustees has "all power necessary to assure self-government," which means it has all power necessary to restore self-government, by means of such things, as firing bad apples, issuing warrants, or issuing currency for jobs, grants, and matters of public interest, such as public funding of elections, thereby, self-funding its operations without additional taxes.
