- e) Green Tables and Bleachers-have been bought. Recreation Committee approved. Advisory Committee approved. Tennis to pay half which is \$1900. HOA went to Bingo to ask for the \$1900 and was turned down. Discussion followed as to how we can help Bingo. Suggestion was to have 6 tennis guys attend each Bingo session(Thursday's) from November through February, to set up and take down tables. We could assign each tennis level a week, for example 1.5's one week, 2.0's one week, and so on. Each level would end up doing this 2-3 times during the season. We also felt that we are asking a lot from our members to volunteer for tennis stuff and should not ask them for more. If this is the case, then the Club will not get money from Bingo. We will have the Club members decide what to do.
