Beginning balance as of 05.01.2025 was \$11,759.77. May income totaled \$1,746.04. May expenses totaled \$17,515.03. Ending balance as of 05.31.2025 was -\$4,009.22. Beginning balance as of 06.01.2025 was -\$5,256.61. June income totaled \$0.00. June expenses totaled -\$1,587.39. Ending balance as of 06.30.2025 was -\$3,669.22. Beginning balance as of 07.01.2025 was \$0.00. July income totaled \$376.00. July expenses totaled \$5,943.37. Ending balance as of 07.31.2025 was -\$5,567.37.

MOTION: Sheree Corbett, Executive Vice President, moved to approve checks #8308-8337, cashiers checks 7291 & 7293, and Electronic Fund Transfer payments as presented. **ADOPTED.**

Sheree Corbett, Executive Vice President, and Justin Garosi, Treasurer, presented the 2025-2026 Budget Proposal.
