1. Call to Order

Policy 5334 / 5334P – Vacation Leave

Buster Styer moved, and Hayley Jenkins seconded the motion to include the following language in Policy 5334/5334P-Vacation: *“Classified staff shall utilize accrued leave when absent under this policy. Classified staff is not permitted to take unpaid leave when the employee has accrued vacation leave available for use. Requests for unpaid leave when accrued vacation leave is available shall be denied unless approved by the Board in accordance with Policy 5329”*. The motion passed unanimously.

7. New Business:

Senior Trip 2024

Clay Pendergrass presented the board with his plans for his Senior Trip. Buster Styer moved, and Trevor Gervais seconded the motion to approve the VRBO rental on Flathead Lake from August 5 – 10, 2024. The motion passed unanimously.

General Fund Election Levy

Buster Styer moved, and Trevor Gervais seconded the motion to cancel the General Fund Levy election because the non-voted and voted amounts are the same as per the Preliminary Budget OPI sent out. The motion passed unanimously.

2024 – 2025 Daycare Lease

Buster Styer moved, and Hayley Jenkins seconded the motion to approve leasing the west room of the elementary school to Meaghan Nolte for \$1 per month to operate a daycare from July 1, 2024, to May 31, 2025. The motion passed unanimously.

Inter-Local Agreement with CMLRCC

Buster Styer moved, and Hayley Jenkins seconded the motion to enter into a 3-year interlocal agreement with the Central Montana Learning Resource Center Cooperative from July 1, 2024, to June 30, 2027. The motion passed unanimously.

Student Attendance Agreement

Hayley Jenkins moved, and Buster Styer seconded the motion to approve the Student Attendance Agreement submitted by Morgan Luther. The motion passed unanimously.

Policy Updates

Trevor Gervais moved, and Buster Styer seconded the motion to **update Policy 1401—Records Available to Public and Policy 4340—Public Access to District Records** as per the MTSBA and include the previously charged fees. The motion passed unanimously.

Policy 3141 – Nonresident Student Enrollment

Buster Styer moved, and Trevor Gervais seconded the motion to keep the submission due date of July 15th but remove NOT in the optional language for late applications. The motion passed unanimously.

Signing Bonus for New Certified Hires

Hayley Jenkins moved, and Buster Styer seconded the motion to approve offering new certified hires a \$2000 signing bonus for the 2024-2025 school year. The motion passed unanimously.

2024-2025 School Calendar

Trevor Gervais moved, and Hayley Jenkins seconded the motion to approve the amended school calendar for 2024-2025. The motion passed unanimously.

Buster Styer moved, and Trevor Gervais seconded the motion to accept **Meaghan Nolte's resignation**. Motion passed.

Hayley Jenkins moved, and Buster Styer seconded the motion to open the elementary teaching position. Motion passed.

Buster Styer moved, and Hayley Jenkins seconded the motion to accept **Connor Tracy's resignation**. Motion passed.

Buster Styer moved, and Trevor Gervais seconded the motion to open the History teaching position. Motion passed.

Buster Styer moved, and Trevor Gervais seconded the motion to accept Ginger Zieglovsky's resignation. Motion passed.

Buster Styer moved, and Hayley Jenkins seconded the motion to open the math teacher position. Motion passed.

Recommendation for New Hire
