A [Deferred Action for Childhood Arrivals \(DACA\)](#) is best described as temporary relief for undocumented individuals who were brought to the United States as children. DACA gives these undocumented immigrants both protection from deportation and a work permit for two years, subject to renewal. The DACA process is convoluted. - **Temporary Protected Status (TPS):** A foreign country may gain [Temporary Protected Status \(TPS\)](#) if local conditions are unsafe or unstable. Our [Ohio-based immigration lawyers](#) can work with you to determine your eligibility and initiate legal proceedings on your behalf.
- **Cancellation of Removal:** Cancellation of Removal is an immigration benefit that allows permanent and nonpermanent residents to apply to have their status amended from deportable alien to lawfully admitted immigration status. An exacting set of conditions must be met. We're confident we offer the best immigration lawyers in Columbus Ohio when it comes to proving an Ohio resident's eligibility. We can also help with a discretionary **Stay of Removal**, a more temporary measure that buys precious time before pursuing permanently amended immigration status.
- **Immigration appeals:** An appeal is an application to reconsider a denied immigration petition. Immigration appeals require representation from an [immigration lawyer](#) with an immense breadth of experience in the [immigration appeals process](#). - **Naturalization:** Naturalization refers to a lawful permanent resident becoming a US citizen, which is the primary path to citizenship for individuals born outside of the U.S. The naturalization process can be complex, but an experienced [immigration law attorney](#) can help you determine your eligibility and, if you are eligible, help you with the naturalization process.
- **Fiancé(e) petition:** If you are a U.S. citizen seeking to bring your foreign fiancé to the

US to get married, you will need to file an [I-129F, Petition For Alien Fiancé Form](#). This is the first step required to obtain a K-1 nonimmigrant visa for your loved one. - **Petition for alien relative:** Form I-130, officially known as the “Petition for Alien Relative” or simply referred to as the “I-130 petition,” is used to establish that a valid family relationship exists between a US citizen or Green Card holder and a family member. [The procedures guiding an I-130 application are complex and time-consuming.](#) Jay Perez Law [immigration attorneys](#) are experienced in navigating the formidable petition process.
