CALL TO ORDER:

The meeting was called to order at 5:00 P.M. by Dr. Cynthia Rogers, president of the Board.

The Pledge of Allegiance was led by the Oaklawn STEM Magnet Elementary School choir and Mrs. Kelley Lovelady, Director. The choir also performed a melody of Christmas songs.

ITEMS OF ACTION:

Dr. Rogers called for a motion to approve the October 19, 2021 minutes. Mr. Lenox made the motion and Mrs. Ugbade seconded. The motion passed 4-0 vote.

Mr. David White presented the Financial Report, after discussion, Dr. Nehus recommended the Financial Report for approval. Mr. Ugbade made the motion and Mrs. Hill seconded. The motion passed 4-0 vote.

Dr. Nehus recommended the Purchase and Installation of a new security camera system at the Gardner Facility located at 525 Hammond Lane. The services will be provided by Blue Sky Technologies, Jonesboro, AR and the total estimated cost is \$84,762.99. Mrs. Ugbade made the motion to approve the recommendation. Mr. Lenox seconded. The motion passed 4-0 vote.
