 - There will be 6 preliminary rounds in all divisions of Policy Debate

Policy Debate

2024-2025 CEDA Debate Topic | 9-3-6 Speech Times | 10-Minute Prep Time

We will offer 3 divisions of Policy Debate, each with 6 preliminary rounds of competition. The Open division will break to Double Octofinals, while the first elimination round in the Novice and Wildcat divisions will be determined by their respective entry levels. Teams will flip for sides in all elimination rounds, unless they have met previously; no breaking brackets.

- **Novice:** Novice competitors are in their first year of college debate and may only present evidence included in the ADA Novice Curriculum Committee's 2024-2025 evidence packet; no outside evidence is permitted in CX-N
- **Wildcat:** Wildcat competitors are in their first or second year of college debate
- **Open:** Open competitors are in any year of their college-debate career; CX-O is open to all eligible debaters, regardless of experience or skill level

This year, we will allow online entries and judges. Online teams must adhere to all applicable rules and policies, including judge obligations, and are eligible for speaker awards and elimination rounds. Judges can be in-person or online to cover their school's entries.

Rules & Procedures

All participating teams are expected to contribute to Open Caselist [here](#) and provide up-to-date information on their affirmative/negative positions by Tuesday, September 24.

For the purposes of ADA tournaments, a debate team is defined as the two-person team that begins the first round of the tournament and who debate together throughout the course of the tournament. If one of the debaters of a team cannot debate in any given round, that round will be forfeited. To debate in a round is defined as to give one constructive speech and one rebuttal. Teams that forfeit rounds will be given average speaker points. Teams that forfeit rounds are ineligible to clear to elimination rounds if they miss more than 1/3rd of their rounds rounded down to the nearest whole round. The debate may still occur for educational purposes. However, that team will still be eligible for speaker awards and elimination rounds. Hybrid teams are allowed at the discretion of the tournament director and are allowed to clear to elimination rounds at the discretion of the tournament director.

Teams from the University of Kentucky are eligible to compete in 2024 JW Patterson Debates, including elimination rounds, and receive speaker awards. Individuals affiliated with the University will not participate in any requisite tabulation decisions for rounds involving UK teams.

The tournament abides by the rules and norms of the American Forensics Association and the American Debate Association.

Debate rounds are open to registered tournament participants.

Tabulation & Judging

Nick Ryan will oversee tabulation of the 2024 JW Patterson Debates. The tournament remains committed to promoting judge diversity and providing a quality experience for all participants.

Judges will be ranked ordinally. Judges in the top 75% of a team's rankings will be placed based on mutuality *of the percentile in relation to rounds in the pool*. The tournament will aim for within 25% mutuality. The lowest 25% will be considered strikes.

Prelim preference sheets will be used throughout elimination rounds on Monday, September 30—unless judge availability necessitates dipping below the strike percentile, in which case strike cards will be distributed, with the number of judges depending on availability. The tab room will accept ballots only from the exact judge(s) assigned to any given round.

Judge Expectations

We require 3 rounds of judging per entry. All coaches are expected to make themselves available for at least a 2-round judging commitment, barring reasonable accommodations. **All judges are obligated through Octofinals on Monday, September 30, then 1 round beyond the elimination of your program's last entry.** All judging for hire should be arranged via the hiring system on Tabroom.

Judges are expected to have college policy debate experience.

Judges must vote for a single team in each round, as well as submit their decision within 2 hours and 15 minutes of the posted start time for all rounds. This time limit will be strictly enforced.

Judges and competitors should enter constraints on Tabroom under the following circumstances.

- If you are former college or high-school debate colleagues
- If you have a substantial fiduciary relationship with the school or program
- If you have had a professional student/coach relationship, or a non-platonic personal relationship
- If you have been a party to a harassment, discrimination, or similar complaint filed with an educational institution, intercollegiate debate association, or other entity charged with resolving grievances of this nature

Participant Conduct

All debaters, judges, coaches, observers, staff members, and other individuals present at the 2024 JW Patterson Debates, or participating in activities associated with the tournament, are expected to know and required to abide by this policy. Participants should also adhere to the policies and procedures of their own educational institutions, as well as all local, state, and federal laws, avoiding discrimination or harassment on any basis prohibited or regulated by law or applicable policies.

Participants should recognize the rights of others and treat debaters, judges, coaches, observers, staff members, tournament hosts, and other individuals with respect. Communication or conduct that fosters ill will toward forensics is a disservice to all and should be avoided.

The tournament follows all University of Kentucky policies and procedures on harassment and discrimination. A compliance officer with the Office of Institutional Equity & Equal Opportunity will be on call for the duration of the tournament. The Tournament Director must first be contacted if an issue involving allegations of harassment and/or discrimination arises.

All participants, including program directors, researchers, and assistants, must ensure their conduct complies with this policy throughout the tournament and avoid, mitigate, and prevent situations that may generate harassment, discriminatory, and/or offensive actions, including during any post-round explanation or reason for decision in a particular round. Coaches and program directors are encouraged to discuss this policy with all of their school's participants prior to the tournament, and are expected to take any reasonable and necessary action to ensure compliance by individuals affiliated with their institution. By participating in the tournament and/or activities associated with the tournament, each individual shall be deemed to have agreed to comport themselves in accordance with this policy.
