## Annexure 3

## CRIMINAL CHARGES AGAINST FACULTY AND STUDENTS

This table covers cases where faculty and students have been jailed for long periods under serious charges and cases where they have been named in First Information Reports (FIRs) or charge sheets, or where they have been questioned by the police. The aim is to show how increasingly, serious criminal charges are being applied to dissent. The faculty who have been jailed under UAPA have been denied bail despite having serious medical conditions; some have not been given bail even to attend the last rites of their parents. In several cases, people have been denied books and other materials, violating their basic rights and identity as academics.

This table is not exhaustive, merely illustrative.
