## Channel 99|History

Channel 99 was founded in what is now known as Rowlett County, Texas by Edward Bee(aged 24). At the time it was known as KERA-TV Channel-88. It featured cartoon programs and the morning, noontime, and evening news at 6:00 AM, 12:00PM, and 6:00PM.

1960s: Edward adds extra staff for the channel, this time they're making sure they have sign-off cards for the time. The EBS Watch also started here. A service assistant, Laming Paul Tonn, also works his way up to the assistant to the Founder. The name is changed to KERA-TEXTV, or KERA TEXas TeleVision. The station is also the first station to broadcast with colour in TEXAS. Laming also gave the station number to be 99 at this time (1961), but Channel 88 still stook around as 99's broadcasting channel. There is no physical or even digital logo for Channel 88 in the series.

The name is changed to NLPI-AUTV. Edward recommends expanding to other locations. The hijacks begin here from an alternate source.

KERA also manages to gain Penrith and Sydney's stations. Channel 89 does experience technical difficulties at one point in the future due to this event. It is unclear why.

reddy Fazbear's Pizza is back in the public eye this year, but not for the reasons they had hoped, as the small business was dragged into a torrent of anger and suspicion due to alleged ties to the disappearance of a local high school student on October 9th. The young teen, known to friends as a hobbyist filmmaker and described by some as a "quiet but well-mannered soul", was reported missing the morning after leaving home to "meet up with someone for a new project" that, according to family, involved the restaurant's infamous string of incidents and general dark reputation.

When pressed for comment, an intern at the establishment stated: "We really had nothing to do with it! Our surveillance cameras showed no one entering or leaving (the restaurant) during that night..." An answer that did nothing but grow more suspicion, as access to the aforementioned footage was immediately denied to the public.

## Town residents were further outraged the following week, as they found multiple job flyers for the restaurant being left at their doorsteps.

## 2000s:

Analog Television starts to die down as a fully functional thing. However, the station stays with its analog service until 2022... we think.

Edward disappears from the studio, and his whereabouts are unknown. He is presumed dead, and Lagon takes the role. Channel 88 completely changes to 99 at this time.

KERA-TEXTV is the last attempt at keeping Analog Television alive. Unfortunately, by 2013, all other Analog Stations go to Digital. The Texas Government recommends to Channel 99 that they go digital too, however they stay with an analog station until 2019, where they use Analog only in Garland, Werrington and a portion of Bellwood.

Lachlan MC Magee takes control of Channel 99, managing to claim all data from its previous services. Lagon and Edward still have their names put on some portions of the transmissions, however. To this day, Goldbox/LCMC Productions Inc owns all the tapes and broadcasts that Channel 99 creates or broadcasts.
