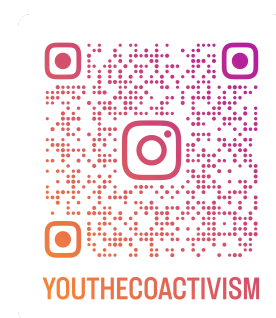

The project

FIRST OPERATIONS

In France, a non-profit association is created under the **Law of 1 July 1901**.

Basic steps

- Gather at least 2 founding members
- Define the purpose of the association
- Choose the association's name
- Draft the statutes
- Hold a founding general assembly
- Declare the association to the authorities
- Publish the creation notice
- Open a bank account

After declaration, the association acquires legal personality.

WHAT THE STATUTES MUST CONTAIN

The statutes must include:

- Name of the association
- Purpose and activities
- Registered office address
- Duration (limited or unlimited)
- Membership conditions
- Governance bodies (general assembly, board)
- Rules for decision-making
- Financial rules
- Conditions for dissolution

The statutes must be signed by the founding members.

DECLARATION OF THE ASSOCIATION

The declaration is done:

- Online via service-public.fr
- Or through the local prefecture (Préfecture / Sous-Préfecture)

Documents required:

- Signed statutes
- Minutes of the founding general assembly signed
- List of board members

Once declared, the association receives a **RNA number**.

PUBLICATION

- The association must be published in the **Journal Officiel des Associations (JOAFE)**
→ [Site du Journal Officiel](https://www.journal-officiel.fr/)
 - Publication is automatic when declaring online
 - This step gives public visibility and legal recognition

GOVERNMENT AUTHORITIES

- Préfecture or Sous-Préfecture
- [Service-public.fr](https://service-public.fr) platform

A notary is **not required**.

TAX & ADMINISTRATIVE STATUS

- Associations are non-profit by default
- A **SIREN / SIRET number** is required if the association:
 - Applies for public funding
 - Employs staff
 - Has significant financial activity

The SIRET number is requested from **INSEE**.

BANK ACCOUNT

To open a bank account in France, you need:

- Statutes
- Declaration receipt
- JOAFE publication
- ID of the president and treasurer
- Minutes of the general assembly

COSTS

- Declaration: free
- Publication in JOAFE: free
- Bank account fees: vary depending on the bank
