Personal information we collect

We collect the following information:

- (1)the model, type, version, brand, language and operating system of device.
- (2)device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- (3)behavioral usage of the App.
- (4)the type and operator of network.

How we use your information

We use your personal information for a variety of business purposes, including:
