

# Privacy Policy for Slime Haven

This Privacy Policy describes how information is collected, used, and disclosed by Slime Haven, a property of Muse Entertainment and Nomina Games, ("we," "us," or "our") when you access or use our game, Slime Haven, available on the Google Play Store ("the Game"). ## Information We Collect:

### 1. Information You Provide:

##### 1. Service Providers:
