We completed a Seed funding round earlier this year, raising ~\$10 Million to-date, and are backed by investors including Stray Dog Capital, VegInvest, Selva Ventures, Vanterra Capital, Beyond Impact, among others. Nowadays also received a strategic investment from Standard Meat Company, a large 4th generation, family-owned meat manufacturer in Texas.

Our first product, a clean label "chicken" nugget, has gained quick traction in direct-to-consumer and retail grocery channels driven by consumer desire for more nutritious and delicious alternatives to conventional meat. In 2023, Nowadays will launch larger format, clean-label, whole-cuts that are poised to unlock significant opportunity for foodservice expansion. These new larger cuts will come either finished or unfinished ready for an operator or contract feeder to add their own custom breading solution. We're excited to launch a truly differentiated plant-based meat solution that better meets foodservice industry needs for menu swapability with the taste experience and nutritional credentials eaters are seeking.
