MigrationWatchUK: "The CReAM paper claimed that, between 2001 and 2011, recent migrants from Eastern Europe had made a net contribution of £5 billion to the Treasury. However, a detailed examination shows that this is based on most optimistic assumptions, some of which are simply incredible. For example, to obtain that result the researchers had to assume that even the most recently arrived migrants have stakes in UK business assets equal to those of life long residents and that, therefore, they can be treated as paying corporate taxes and business rates to the same extent."
