By purchasing my art services, you automatically agree to the following conditions. You are agreeing that you have read them and accept them all. If you do not read them, that is on you.

Please read this entirely and carefully.

Please keep in mind that my TOS may be subject to minor or major changes as I grow and learn about myself and my art, eg. finding more things that I should add to my WILL NOT DRAW list. I have the right to change my rules whenever I feel like it needs to be updated/changed. I will inform any commissioners about any big changes I plan to make.

You do NOT have the right to sell a commission from me for NFT.

I as the artist own 100% of the right to the art itself, not the characters or the subject matter of it.
I do not give permission for my art to be used for NFT or commercial use in general.

I have the right to refuse a commission for whatever reason.

Due to far too many artists being scammed out of their well earned money recently, I've become more hesitant about who I take commissions from. I am also hesitant to take on commissions if the character or situation wanted is too complex for my comfort zone. While I would like to test my limits, when it comes to paid work, I will only do what I know I can work with, to give the customer the best I can offer.

You are allowed to repost commissions/art trades/requests/gift art you get from me.

This is so long as it is the watermarked version that I post, with proper credit, and not for a profit.

I take full payment BEFORE starting on your artwork.

If a payment plan is needed, we can work that out in DMs, but if you do not want to pay until I am finished, I will refuse your commission. This is purely to protect myself. I will not send a final piece until I have been fully paid.

Do not ask me to draw in another style.

You are commissioning me for my style. If you want art in someone else's style, please ask them instead.

**My designs/artwork/characters should not be given away to people I have
blocked/blacklisted.**

I recognize that I cannot legally enforce this, and I will not try to, so this is here as a personal preference.

If you purchase an adopt, buy a design, get a custom, or anything that involves my work, I ask for it to not be given to any person that I have blacklisted for any reason. Please ask me before selling/gifting/etc anything of mine so that I can check to make sure they are not blacklisted, and so I can keep up with where my work is.

Please do not change my designs/adopts/etc to an unrecognizable point.

I recognize that I cannot legally enforce this, and I will not try to, so this is here as a personal preference.

I don't mind if you add/take colours, or if you move markings, or if you swap colours etc. Just please do not make it look like a completely different character. You buy the designs because you like them, not to change them to suit you. In that case, please just make your own or find one that properly suits what you're looking for. Keep in mind, I do make customs.

Please do not sell my designs/adopts/etc for more than you paid.

I recognize that I cannot legally enforce this, and I will not try to, so this is here as a personal preference.

This is honestly just very rude to myself and whoever buys the adopt from you. Please only ask for what you paid. The only exception should be if there is extra art involved, which can up the price to a certain extent.

Please do not ask for an ETA of your commission.

I often get motivation issues, but otherwise, I do work fairly quickly, so I won't be able to give you an exact answer. If you want it finished by a certain time/date, please make sure to come to me a week in advance. Unless you have given me a due date, please do not rush me. It makes me uncomfortable and will make me more likely to terminate the commission.

Please tell me in your first DM/email if you'd like process pictures of your commission.

Doing so will cause me to work slower on your piece as I have to wait on your okay before continuing, so it is much easier for me to work all at once, but I can understand wanting WIPs. While in the sketch stage, you are allowed ONE full resketch of your commission (eg. a different pose/idea/character) as well as three smaller changes. After that, I will have to charge a fee for any further charges. If you exceed a certain amount, I will terminate the commission and refund you up to whatever state the commission as in. This is due to the fact I have seen people being scammed so that the person ended up making off with many different sketches/poses/etc that they would normally pay extra for.

I will give refunds, but it will vary depending on the situation and the state of the commission when you decide to ask for one.

You will have plenty of time to ask for one before I finish, but once the commission has passed the flat colours stage, I will not give you one. As I said, you'll be given plenty of time to tell me you want a refund, so please take advantage of that if you need to. If you decide halfway that you no longer want the commission, I will refund you up to whatever state the commission is in. For example, if I have not started yet, I will refund you fully. If it is at the sketching stage, I will refund you up to the price of the sketch, meaning you will have paid for the sketch instead of the full piece. Again, once it is past the flat colour stage, I will not give a refund and will instead finish or scrap the piece, whichever you prefer.

I will only be doing digital until further notice.

No, I will not be sending any art through the mail. I can email you a higher resolution picture with and without the background/watermark. Again, please only post the watermarked version.
