# Missisquoi Valley School District Board Meeting Minutes Highgate Central School Library April 25, 2023 6:00pm

**Location:** The MVSD Board and Administration participated at the Highgate Central School Library for this meeting. The meeting was held hybrid with remote access for the community and other interested persons.

  - Jen Chevalier, School Board Chair, called the meeting to order at 6:02PM

### 5) Facility Committee Update

Peter Magnant provided an update from the last facilities committee meeting held on April 4<sup>th</sup>. He stated that the Franklin Expansion project is on target to start on June 19<sup>th</sup>. Some of the offices will be displaced, so they are being temporarily relocated to the library. They will need partitions for temporary offices for privacy and security purposes. They were able to obtain a quote for \$40,000 for temporary offices that are in addition to the cost of the project. They will use either surplus funds or ESSER funds to pay for this additional cost. They will use a gravel path to enter the school from the side of the building. They are looking at the same camera system that will be the same for all the buildings. The MVU Roof Phase 2 is scheduled to begin as planned. The Highgate Boiler system project is starting during April break. This is not a boiler replacement but updating the controls to maintain distribution of heat more evenly. They hope to have it up and running by the end of October. They are planning to start on June 19<sup>th</sup> on the Highgate Kitchen Hood project. The MVU sign has been ordered and they are

making arrangements for the electrical work and getting quotes on the stone work. Don commented that there is an amazing amount of work going on. It sends a message to the community that it is important to get our buildings up to par.

Julie Regimbal went over the following bills that they are monitoring closely:

## 7) Resolution

Jen Chevalier sought input from the board on if they would like to submit a resolution to the Vermont School Board's Association (VSBA) for their consideration. Resolutions are positions taken by the association on issues of importance to Vermont school boards. They may include recommendations for action by the VSBA. Don Collins has thought that consideration for a four-year-old program would have to include a 10-hour day because there will be an issue of no child care after school. He felt there was too little support for this and so did not want to submit it. Tobias Maguire expressed his frustration that the VPA has no public oversight and they have too much control especially around extra-curricular activities. When there are issues around an activity, you can contact them and provide your input but because of the lack of accountability to a public body such as a board, they can make a decision and it becomes final. Lora McAllister stated the issues around the teacher retirement fund requiring the district to pay 26% to the State on grant funded positions. She felt that the State should take it off the top prior to the distribution of the grant. Renick Darnell-Martin felt that this may be a good resolution. Jen Chevalier asked the administration to draft a resolution that would reflect this change.

## 8) Board Meeting Sites next school year

Jen Chevalier asked the board if they would like to continue the current site rotation of going to each school for the two meetings each month or go back to the previous rotation of going to MVU for the first meeting of the month and rotating elementary schools for the second meeting of the month? Board members weighed in on their preferences with many wanting to go back to the previous format. Joanne Johnston requested that we continue to hear from students

regardless of which rotation was chosen. Renick suggested that the board continue this discussion at their retreat in July.

### 9) New Teacher Hires

Julie Regimbal and Bonnie Moulton went over the hiring procedures of the professional staff. Tobias Maguire asked about the retention of the staff now that they have implemented the new salary scale. Bonnie reported that they have the same percentage of retention as last year for teachers. They had less retirements this year but they did have many one-year position contracts that they had to fill. They retained 83% of the professional staff. Bonnie distributed written exit interview surveys with 40% choosing to do in person interviews with her. She has shared the data with the principals and the Superintendent. Board members requested seeing the data on why the teachers left for a future board meeting.

Julie would like to change the date to July 12<sup>th</sup> instead of July 11th so that they can reserve The Abbey as the venue.
