General Eligibility Requirements: For initial eligibility of a position, individual MUST be equal or higher in grade than the position. Selectee must live in or near the community of Ellsworth AFB, SD. There is a three year mandatory stabilization tour required upon graduation of Civil Support Skills Course (CSSC). **Applicants must be fully vaccinated or have a pending/approved exemption in order to apply.**

Job Description: Manages all WMD CST training programs including DTMS, DTS ATRRs, and additional systems required by NGB. Prepare operations and fragmentary orders and maintains the WMD-CST system to track the certifications of personnel expected to enter the WMD incident site. Assists the Senior Operations NCO in the accomplishment of operational control for the WMD-CST actions throughout a response. Acts as the command central point of contact for all lessons learned during deployment. Coordinates all training requirements for WMD-CST individual personnel and team training events.

Any application not sent in this format will not be accepted and will be sent back. E-mail must be dated no later than the closing date of this notice.

IAW Para 10 SDNG Title 32 AGR Stabilization Policy dated 6 Dec 19, a copy of the Exception to Policy memo endorsed by Bn and Grp AO or Directorate must accompany your application if you have been in your current position less than 18 months or have been branch qualified in your current position less than 18 months.

B.
