Parking/Bus Drop Off: Busses may drop teams off in the parking lot adjacent to the tennis courts at Mukwonago High School (entrance #1). Team camps are located to the northeast of the starting line. **Please inform your spectators that they may not park in the adjacent neighborhoods and should use the high school parking lots.**
