- a. Josh: Kevin Hoffman taking lead on Prevention Priority list and Limited Distribution list for HDOA.*
- b. Josh: HISC will be moving forward on Olelo video public access mini-series in 2020.*
- c. Jonathan:*
 - i. 2019 Xmas trees: 168 scheduled containers done. Mostly larger 40' containers vs 24' boxes. Approx. 190,000 trees. 158 containers from OR. Only 10 from WA. Only 4 containers detained.*
 - ii. Alligator lizard found in Hilo Christmas tree.*
 - iii. Coqui frogs:*
 - 1. Still dealing with coqui infestation in Palolo nursery.*
 - a. Sprayed citric acid 4 times. About 2k gallons total.*
 - 2. Waimanalo has coqui at 2 sites.*

- i. PrePro1.1- Implement a comprehensive e-manifest.*
 - 1. Trying to roll-out on 12/16. Rolling-out 9 components in phases. eManifest will be the first. (eManifest, Export, Import, Interisland, Investigation, Permitting, Phytosanitary Certificates, Pest Hotline, Certified Nursery) Full roll-out by the end of March.*
 - 2. There will be a transition phase for the staff as they move out of paper reporting to the automated system. Mobile component with tablets.*
 - 3. Working with ETS/Enterprise Technology Services, Office of Change Management.*
