VIII. New Business (5 minutes total)

- **A. Group Dominance (5 minutes) -** (Agenda Owners: Rose W./Rhona, not discussed yet)
 - 1. Suggestion to add to our format the following statement: "If you read or shared at yesterday's meeting, we ask you to hold back so that others may have the opportunity to read or share. Participation is the key to harmony."
 - 2. Some feel that the trend of lengthy daily updates unrelated to alcoholism from certain individuals may unintentionally dominate the conversation, limiting time for newcomers, those in crisis, and others to participate in ways that closely align with Al-Anon's purpose. Members can be encouraged to focus on the readings or on issues related to living with or supporting someone affected by alcoholism.
- **B. Sponsorship** (Agenda Owner: Tori P., not discussed yet)
 - 1. Proposal to incorporate a dedicated section for willing sponsors in our meeting script and phone list. Aligning with the core principle of Al Anon to pay it forward after working the steps, this addition aims to foster a supportive environment for those seeking guidance in their recovery journey.
- C. Weekly Tradition Study (Agenda Owner: Candis C, not discussed yet)
 - 1. Proposal for weekly study sessions on the Traditions from "How Al-Anon Works" with shared reading duties, aiming to foster personal growth among members. Following the completion of the Tradition study, the group plans to transition into studying the steps, highlighting the

- significance of focusing on the program for collective recovery and individual progress.

 - 1. Proposal to implement a practice to mute or remove individuals who call each other out by name in the chat over disagreements, as it can be embarrassing and detract from creating a welcoming, safe space.

- **A. Group Inventory with External Facilitator** (Agenda Owner: Rebecca C, discussed in Business Meeting on 09.24.23, 11.30.23, 10.31.24, 1.31.25)
 - 1. In previous discussions, the group voted to have a group inventory and to follow the recommendations of an experienced inventory facilitator. At the January meeting it was decided to have Judy, Group Representative, ask the WSO for support in obtaining a skilled facilitator, which was voted on and passed with 17 in favor and 1 opposed.
- **B. AA's Big Book and 12X12** (Agenda Owner: Amy C., Discussed in Business Meeting on 11.30.23)
 - 1. The group is considering whether to reference AA's Big Book and 12X12 in their meetings to allow members to share insights, strength, and hope gained from these texts. At the first discussion, there was a consensus within the group to maintain focus within Al-Anon and discourage reading from the AA book during their meetings. Instead, they recommend interested individuals attend dedicated Al-Anon Big Book meetings to preserve the distinct nature of Al-Anon meetings. Possible motion: Constrain references to literature to Al-Anon literature only.
