

Subscription Agreement

Welcome to FunPic. This Subscription Agreement clarifies the relevant provisions regarding subscription services in connection with your use of the FunPic App. By downloading, installing, and using the App, you acknowledge that you have read, understood, and agreed to be bound by this Agreement, as well as our FunPic User Agreement and Privacy Policy. If you do not agree to any terms of this Agreement, please do not use the App.

1. Statement on Subscription Services

1.1 Currently, FunPic does not provide any paid subscription services (including but not limited to membership packages, premium function subscriptions, etc.). All core functions and built-in materials of the App are provided to you for free, and you can use them directly without any subscription or payment.

1.2 We reserve the right to launch subscription services in the future. If we decide to add paid subscription functions to the App, we will issue a revised version of this Agreement and notify you through in-app notifications or other reasonable means before the launch. The revised Agreement will clearly specify the content, pricing, rights and obligations related to the subscription services. Your use of the subscription services after the launch will be deemed as your acceptance of the revised Agreement.

2. Intellectual Property Rights Related to Future Subscription Services

2.1 If we launch subscription services in the future, the premium materials and functions included in the subscription services will be protected by intellectual property laws. Without our prior written permission, you may not copy, modify, distribute, transfer, resell, or use the premium content obtained through subscription for commercial purposes (such as advertising, commercial promotion, or profit-making activities).

2.2 The user-generated content (UGC) you create using the App (including the content created with future subscription services) shall be your responsibility. You shall ensure that your UGC does not infringe on the legitimate rights and interests of any third party. We will not claim ownership of your UGC, and the relevant rights and obligations of UGC shall be subject to the provisions of the FunPic User Agreement.

3. Disclaimers

3.1 Since the App currently does not provide subscription services, we shall not be liable for any disputes or losses arising from your misunderstanding of the availability of subscription services.

3.2 If we launch subscription services in the future, the services will be provided "as is". We will strive to ensure the stability and normal operation of the subscription services, but we do not guarantee that the services will be free of errors, bugs, or interruptions. We shall not be

liable for any direct or indirect losses caused by the temporary unavailability of the subscription services due to technical failures, system maintenance, or force majeure.

4. Modifications to This Agreement

4.1 We may update this Agreement when adjusting service content (such as launching or modifying subscription services). If we make any material changes, we will display the revised Agreement in the App and indicate the "Last Updated" date. Your continued use of the App after the update will be deemed as your acceptance of the revised Agreement.

4.2 If you do not agree to the revised Agreement after we update it, you may terminate your use of the App by uninstalling it.
